INTRODUCTION

- The Augusta County Service Authority (ACSA) was formed in March of 1966 to centralize the provision of water and sewer service to Augusta County residents.
 In 2023, the ACSA rebranded as Augusta Water. Augusta Water also operates the Augusta Regional Landfill for the three owner localities, Augusta County, Staunton and Waynesboro.
- Over the last 58 years, Augusta Water has grown from 11 employees serving 113 customers, to an organization employing 127 people serving 15,849 water customers and 9,481 sewer customers. Augusta Water also maintains 421 miles of water mains, 2,046 fire hydrants, 236 miles of gravity sewer mains, and 21 miles of sewer force main.
- In addition to our direct commercial, industrial and residential customers, Augusta
 Water serves a diverse group of stakeholders, including, but not limited to
 developers, homebuilders, environmental groups, local governments (Augusta County,
 Staunton and Waynesboro) and School Boards.
- The 2024 Strategic Plan includes updates by senior Augusta Water Staff to the organization's Values, Vision, and Mission Statement. In support of the Vision, the Plan includes updated organizational goals spanning the next two years. The Plan was presented to the Board of Directors at the February 2024 retreat for consideration and comment before receiving final approval at the April 2024 board meeting.

WORK/LIFE BALANCE



Evaluate options for hybrid remote work and flexible scheduling.

- Have Draft Policy to Personnel Committee by July 1, 2024
- Have Final Policy Approved by October 1, 2024

PUBLIC AWARENESS



Budget for and implement an updated website for Augusta Water and dedicated website for Augusta Regional Landfill.

 Include Funding in FY-25 – Complete by March 31, 2025

STAKE HOLDER ENGAGEMENT



Form an "Augusta Water Stakeholders Committee" comprised of both staff and Board members to discuss planning and other long-term goals with the County Board of Supervisors, other members of the County, and other Stakeholders.

- Have Stakeholders Committee members selected by July 1, 2024
- Begin meetings by January 1, 2025

EMPLOYEE DEVELOPMENT



Develop and schedule annual new supervisor and refresher trainings. Evaluate developing or purchasing on-demand training content.

 Have new program ready to implement by January 1, 2025

INFRASTRUCTURE SUSTAINABILITY



Develop master plan/life cycle plan for replacing aging infrastructure and equipment with supporting budget.

- Have Master Plan complete by January 1, 2026
- Include Four-Year Funding in FY-27 Budget Projections

TECHNOLOGY SUSTAINABILITY



Develop master plans, incorporating data use cases, around technology systems, emergency responses, and necessary support functions. In support of the master plans, increase training for software systems (Lucity, Finance Plus, etc.).

- Have Master Plan complete by January 1, 2026
- Include Four-Year Funding in FY-27 Budget Projections

LANDFILL MANAGEMENT




Evaluate purchase of in-house grade control technology for the Augusta Regional Landfill.

- Complete evaluation by January 1, 2025
- Include any Necessary Funding in FY-26 Budget

IMPLEMENTATION DIRECTIVE

This Strategic Plan was developed by the Augusta Water Senior Management Team, with input from staff, and approved by the Augusta Water Board of Directors at the February 15, 2024 Board Meeting.

The intent of this Strategic Plan is to assess our organization's current status and provide specific goals, consistent with our Values, Vision and Mission, to give clear guidance to all our employees.



As with any plan, care must be taken to frequently assess our progress and to periodically revise the plan. This plan covers Fiscal years 2025 through 2027. It is anticipated the plan will be revisited in the summer of 2027 and all prudent updates and revisions will be made.
