

Freddy's Story: Renewed hope through Respiratory Therapy

In one of our Alabama-based partner centers, Freddy is thankful for the renewed hope and independence he has gained through Respiratory Therapy.

Due to an upper esophageal carcinoma, Freddy previously spent several months in a local hospital receiving treatment and, ultimately, a tracheostomy.

Freddy had participated in therapy since his admission to the center, and had a wonderful rehabilitation team looking out for him. During an assessment, Powerback Respiratory Therapist, David Bocka, detected a change in condition. Immediately David started working with the nursing staff and Freddy's physician; unfortunately, the cancer returned.

Freddy returned to the hospital for a monthlong stay to begin chemo and radiation treatments to shrink the tumor. Once back at the center, Freddy began working with both David and another Powerback Respiratory Therapist, Angela Campbell, to strengthen and improve his respiratory endurance.

While he will always need his tracheostomy tube, Freddy can now vocalize with a speaking valve. He enjoys participating in community activities and enjoying the fresh air outdoors.

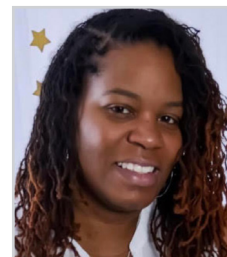
Through the expert care and compassion of our therapists, Freddy has regained independence and improved his quality of life.

Krista's Story: Active Living with Powerback Rehabilitation To You

Krista was a mom of two young kids, a wife, a middle school teacher, and an active yoga enthusiast. 

Access to Therapy Telehealth Services After the Public Health Emergency Expires

Providers and rehabilitation professionals are calling on the Centers for Medicare and Medicaid Services (CMS) to provide clarification of beneficiary access to physical and occupational therapy and speech-language pathology services via telehealth when furnished by institutional providers upon the expiration of the COVID-19 public health emergency (PHE) on May 11th.

Although Section 4113 of the Consolidated Appropriations Act of 2023 (P.L. 117- 328) directed CMS to extend the

beneficiary access to therapy services furnished via telehealth services initiated during the PHE through the end of 2024, CMS has not provided specific guidance to ensure that beneficiaries will continue to have access to these services when furnished by an institutional provider billing Medicare B such as a skilled nursing facility, home health agency or outpatient rehabilitation facility. CMS stated they would provide a FAQ to clarify this issue and are conducting a legal review. However, they offered no timetable as to when this legal review will be complete.

CMS Releases Proposed Skilled Nursing Facility Prospective Payment System (SNF PPS) for fiscal year (FY) 2024

On April 4, 2023, the CMS issued a proposed rule that would update Medicare payment policies and rates for skilled nursing facilities under the Skilled Nursing Facility Prospective Payment System (SNF PPS) for fiscal year (FY) 2024.

In addition, the proposed rule includes proposals for the SNF Quality Reporting Program (QRP) and the SNF Value-Based Purchasing (VBP) Program for FY 2024 and future years.

Finally, this proposed rule would eliminate the requirement for

facilities to waive their right to a hearing in writing actively and instead treat the failure to submit a timely hearing request as a constructive waiver. Therefore, CMS is publishing this proposed rule consistent with the legal requirements to update Medicare payment policies for SNFs annually.

CMS Posts Draft MDS 3.0 RAI Manual Version 1.18.11 and Announces Training Program

The Centers for Medicare & Medicaid Services (CMS) has posted the draft [Minimum Data Set 3.0 \(MDS 3.0\) Resident Assessment Instrument \(RAI\) User's Manual Version 1.18.11](#). The MDS 3.0 RAI User's Manual v1.18.11 will take effect on October 1, 2023. CMS notes that this version of the RAI contains "substantial revisions related to the Improving Medicare Post-Acute Care Transformation Act of 2014 (IMPACT Act), which requires that standardized assessment items be collected across post-acute care (PAC) settings." In addition, CMS has updated the language in the manual to be gender-neutral. CMS has clarified guidance and examples in numerous chapters and appendices to reflect current regulations and best practices.

On May 15, 2023, CMS announced they are offering a virtual training program that

consists of 2 parts:

PART 1: LEARN

Part 1 consists of pre-recorded training webinars that will provide foundational knowledge to assist in learning the new and/or revised items and associated guidance. In addition, a supplemental Case Study is available to give providers additional practice in coding the new and/or modified items. These videos will be on [CMS YouTube](#) and must be viewed in advance of the Part 2 live event.

PART 2: PRACTICE

Part 2 includes the live, virtual workshop sessions that provide practice coding scenarios on select data elements covered in the Part 1 training webinars. These live sessions will occur on June 21, 2023 between 12:30 p.m. and 5 p.m. ET. Registration is open and can be completed online through [Zoom](#).

Additional training resources are located within a ZIP file in the Downloads section of the [SNF Quality Reporting Program \(QRP\) Training page](#). These resources include an acronym list, Action Plan worksheet, Case Study documents, resource guide, and PDF versions of the training webinars.

CMS underscores that it will not issue replacement pages for v1.18.11 due to the scope of the revisions and recommends "those wishing to continue using a physical copy of the manual are encouraged to print the new version." Powerback continues to stay abreast of all updates released by CMS and will provide continuous communication with leadership and staff.
