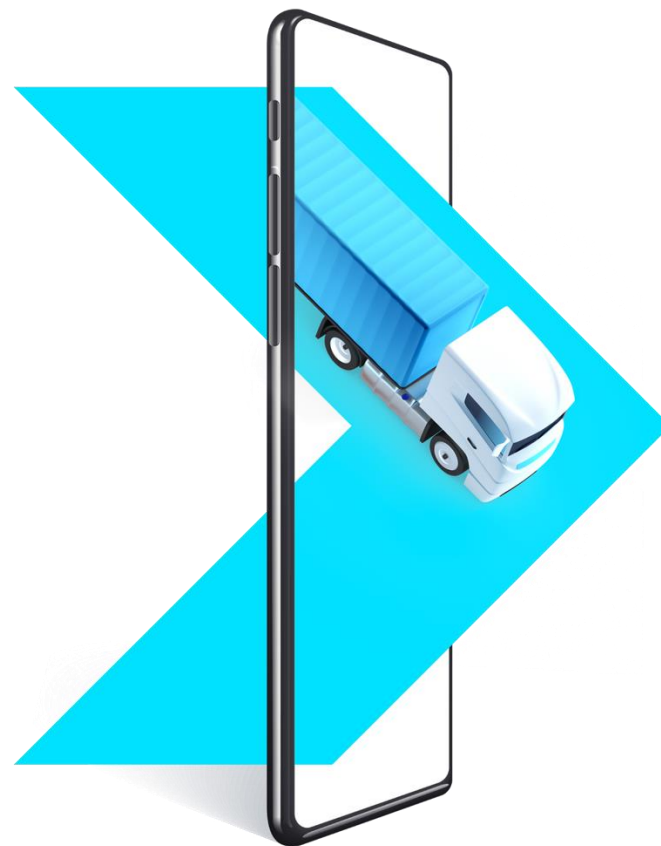

Additional information

The main source of information for each entity were IFRS ledgers in functional currency. This is a change from prior years (until 2023) where local accounting principles' data was reported.

Number of employees is a headcount as of 31 December 2024.

W.A.G. Mobility Solutions Iberia, S.L. UNIPERSONAL, ARRAIA-OIL, S.L., W.A.G. payment solutions Spain, S.L.U. and LISERTECO 24 HORAS, SL are based in the Alava region being part of Spain and together form the corporate income tax group. The tax jurisdiction of the income tax group is Spain.
