Driving under the influence of alcohol with a BAC level (blood alcohol concentration) of 0,2–0,5 g/dl (professional drivers may have a more strict legal limit, BAC of 0.0 g/dl)	589 EUR + temporary suspension of the driving license for 6 to 36 months	2,500 PLN + temporary suspension of the driving license for 6 to 36 months	15
Driving under the influence of alcohol with a BAC level above 0,5 g/dl	is considered a crime: fine depending on income, suspension of the driving license from 1 year up to 10 years, possible imprisonment for up to 2 years, possible vehicle	is considered a crime: fine depending on income, suspension of the driving license from 1 year up to 10 years, possible imprisonment for up to 2 years, possible vehicle confiscation	0

## Electronic toll collection system (passage of vehicles and combinations of vehicles with GVW ≥ 3.5 t)

## Driving periods and breaks

Exceed daily driving time	24 to 130 EUR	100 to 550 PLN	0
Exceed weekly driving time	35 to 130 EUR	150 to 550 PLN	0
Exceed maximum total driving time during 2 consecutive weeks	59 to 165 EUR	250 to 700 PLN	0
Exceed uninterrupted driving time of 4,5 hours before taking the break	24 to 83 EUR	100 to 350 PLN	0

## Other common violations

Failing to create a life corridor in time or using it to bypass a traffic jam	118 EUR	500 PLN	8
Failing to observe the required minimum distance between the vehicle being driven and the car in front in the same lane	71 to 118 EUR	300 to 500 PLN	0
Failing to maintain the required distance behind a vehicle in a tunnel longer than 500 metres	118 EUR	500 PLN	0
Driving through a red light	118 EUR	500 PLN	15
Violating the overtaking ban on a motorway or expressway with only two lanes (truck drivers, category N2 or N3 vehicles)	235 EUR	1,000 PLN	0
Failing to stick to the 2 rightmost lanes on motorways or expressways with 3+ lanes. Pertains to category N2, N3 vehicles, or vehicle combinations over 7 metres in length	118 EUR	500 PLN	0
