3. Promotion period:

The Promotion shall end on **30 April 2026 at 23:59:59 (GMT+1)**. The Promotion may be terminated earlier by the Organizer for valid reasons. Such termination shall not affect orders placed before the termination date. The Organizer reserves the right to extend the promotion period. Any such extension shall not require an amendment to these Terms and Conditions.
4. The Promotion cannot be combined with any other discounts, special offers, or individual pricing agreements, unless explicitly agreed by the Organizer.
5. The Organizer reserves the right to amend these Terms and Conditions for valid reasons, in particular in the event of changes in legal regulations or organizational reasons and force majeure. Any amendments shall not affect rights acquired by participants before the date the changes come into force.
6. All discounts are calculated from the standard price list valid at the time of order date. VAT and other applicable taxes shall be applied in accordance with applicable laws, taking into account in particular the customer's status and, where applicable, the validity of the VAT identification number verified in the VIES system.
