DispersaPro:

DispersaPro is a micronized powder excipient designed to assist in the delivery of various active pharmaceutical ingredients (APIs) used for irrigation and nebulization purposes. DispersaPro powder helps to disperse and solubilize poorly soluble APIs and contains Xylitol, an ingredient that has been studied for its potential utility against biofilms. DispersaPro offers an anhydrous alternative for APIs with unknown or poor stability in aqueous vehicles, allowing patients to open capsules or packets containing DispersaPro immediately prior to use and disperse the powder in an aqueous vehicle for irrigation.
