

IN 2025, THE JFR DISTRIBUTED MORE THAN \$700,000 USD IN DIRECT SUPPORT OF RESCUERS WHO LIVE IN 10 COUNTRIES. FUNDS ARE DISTRIBUTED THREE TIMES DURING THE YEAR. FUNDS ARE DISTRIBUTED TO THE RESCUERS IN A SAFE AND EFFICIENT MANNER. PROCEDURES ARE IN PLACE TO ENSURE THAT THE RESCUERS RECEIVE THEIR FUNDS. PROCEDURES AND SAFEGUARDS ARE ALSO IN PLACE TO ENSURE THAT THE RESCUERS RECEIVING MONTHLY SUPPORT FROM THE JFR ARE STILL ALIVE. THE MAJORITY OF THE RESCUERS RECEIVING FINANCIAL ASSISTANCE LIVE IN EASTERN EUROPE, WITH POLAND HAVING THE LARGEST NUMBER OF RESCUERS. JFR BEGAN SUPPORTING RESCUERS IN THE LATE
