Free of Charge: The words "Free of Charge" do not mean that the Patent Holder is waiving all of its rights with respect to the Patent. Essential patents are patents that would be required to implement a specific Standards Australia document (whether whole or in part).

Assignment/transfer of Patent rights: Declarations made pursuant to Clause 2.1, 2.2, 2.3 or 2.4 of Standards Australia's Patent Policy shall be interpreted as encumbrances that bind all successors-in-interest as to the transferred Patents. Recognising that this interpretation may not apply in all jurisdictions, any Patent Holder who has submitted a declaration according to Standards Australia's Patent Policy - be it selected as option 1, 2, 3 or 4 on the Patent Declaration form - who transfers ownership of a Patent that is subject to such declaration shall include appropriate provisions in the relevant transfer documents to ensure that, as to such transferred Patent, the declaration is binding on the transferee and that the transferee will similarly include appropriate provisions in the event of future transfers with the goal of binding all successors-in-interest.
