

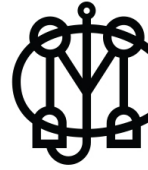

Dear Owners, Developers, and Industry Supporters:

We are pleased to introduce the 2025 Report for the Maryland-Bred Out-of-State Owner/Developer Bonus Program, administered through the Maryland Thoroughbred Purse Account.

This \$600,000 bonus initiative rewards the owners and developers of Maryland-breds competing at Colonial Downs and Delaware Park during the Laurel summer break (July 4–August 16). Bonuses are awarded based on a points system for first, second, and third place finishes in eligible overnight races. Available funds are split equally between Owners and Developers—the Developer being the registered owner at the horse's first career start.

Since its inception, this program has helped strengthen Maryland's breeding and racing community—complementing our year-round 30% Maryland-bred bonus at in-state tracks. In total, more than \$56 million in Maryland-bred bonuses have been distributed by the Maryland Thoroughbred Purse Account since 2014.

# PROGRAM DETAILS

**BONUS POOL:** \$600,000 (\$300,000 Owners and \$300,000 Developers).

**ELIGIBILITY:** Registered Maryland-bred horses finishing first, second, or third in non-restricted over-night races (excluding stakes, certified, or state-bred restricted races) at Colonial Downs and Delaware Park during the eligibility period of July 4, 2025 through August 17, 2025.

**PAYOUT CALCULATION:** The bonus pool will be divided by the total number of points earned across all eligible races. Each horse's bonus will be calculated based on its total points and will be equally distributed between the Owner(s) and Developer(s). The Developer is defined as the owner at the horse's first career start.

## POINTS SYSTEM FOR BONUS DISTRIBUTION

Bonuses will be awarded based on a four-tiered system that assigns points based on Maryland purse equivalents:

Level	Categories	Maryland Purse	Points for 1st-2nd-3rd Place
A	No price; CLM \$50,000 & Up	\$47,000 & Up	10 pts. - 5 pts. – 2.5 pts.
B	CLM \$30,000 - \$45,000	\$33,000 - \$41,000	8 pts. – 4 pts. – 2 pts.
C	CLM \$16,000 - \$25,000	\$26,000 - \$30,000	6 pts. – 3 pts. – 1.5 pts.
D	CLM \$5,000 - \$12,500	\$15,500 - \$24,000	4 pts. – 2 pts. – 1 pt.

- Starter Handicaps will receive points equivalent to two claiming levels higher (e.g., a \$5,000 Starter Handicap earns CLM \$12,500 points).
- No bonuses will be awarded for stakes races, certified races, or state-bred restricted races.





# MARYLAND-BRED OUT OF STATE BONUS PROGRAM DELIVERS BIG RETURNS IN 2025 IN FIRST YEAR

The new Maryland-Bred Out-of-State Owner and Developer Bonus Program proved its worth in its inaugural year in 2025, offering a timely and innovative incentive for horsemen and breeders who campaigned Maryland-breds at Colonial Downs and Delaware Park.

Despite weather cancellations, unusual race outcomes, and a fiercely competitive Mid-Atlantic racing season, the program distributed a total of \$600,000 in bonuses, underscoring its role as a vital financial lifeline for owners and developers during Maryland's two-month racing hiatus. The program began July 4 and concluded August 16.

That pause in live racing was a strategic decision. With the Maryland Thoroughbred Purse Account assuming additional financial responsibilities tied to the Pimlico Plus plan—the long-term initiative designed to secure Maryland racing for the next generation—the MTHA Board of Directors unanimously determined it was prudent to contract racing days during the summer in order to preserve funds to sustain racing and purses throughout the remainder of the year.

Choosing the summer window ensured horsemen had nearby alternatives in the Mid-Atlantic region, rather than leaving them without the same plethora of options during the winter months when little viable alternatives exist. The new bonus program guaranteed that even as Maryland tracks went dark, Maryland-breds and their connections remained supported and rewarded.

Launched by the MTHA Board of Directors to strengthen the state's racing and breeding industries, the program provides awards to both owners who race Maryland-breds outside the state and to the developers responsible for producing them. (A developer is defined as the person who owned a horse at the time of its first career start.)



DELAWARE PARK



This initiative expands upon Maryland's popular Owner/Developer Bonus Program, which pays a 15% bonus to owners of Maryland-breds and a 15% bonus to developers for open overnight races at Laurel Park, Pimlico Race Course, and Timonium. By extending bonus eligibility to neighboring Mid-Atlantic tracks during Laurel Park's hiatus, the new program broadened financial opportunities while reinforcing the value of investing in Maryland-breds and developing horses—even when racing shifted across state lines.

In its first year, payouts were concentrated at Delaware Park and Colonial Downs, two venues where Maryland horsemen have long maintained a strong presence. The results spoke volumes: Maryland-breds not only held their own across both tracks but also benefited from a bonus structure that delivered much-needed stability in a summer marked by disruption.

At Delaware Park, two full race cards were canceled—one in late July due to extreme heat and another at the end of the month because of severe thunderstorms. Meanwhile, Colonial Downs opened its meet with the rare drama of a double dead heat—three of the four horses involved were Maryland-breds—a statistical oddity that underscored both the depth of Maryland's program and the inherent unpredictability of the sport.

As with Maryland's traditional Maryland-bred bonus program, disbursements will follow familiar procedures. Owner bonuses will appear directly in each owner's Maryland inCompass account, while developer bonuses will be mailed as checks to the managing partner of record. All payments are expected to be distributed in early September.

Through it all, Maryland horsemen continued to thrive, and the state's bonus programs ensured the money kept flowing back into the racing community. The inaugural year proved that the new initiative is not only viable—it is already becoming an essential tool in sustaining Maryland's racing ecosystem and advancing the long-term vision of the Pimlico Plus plan.

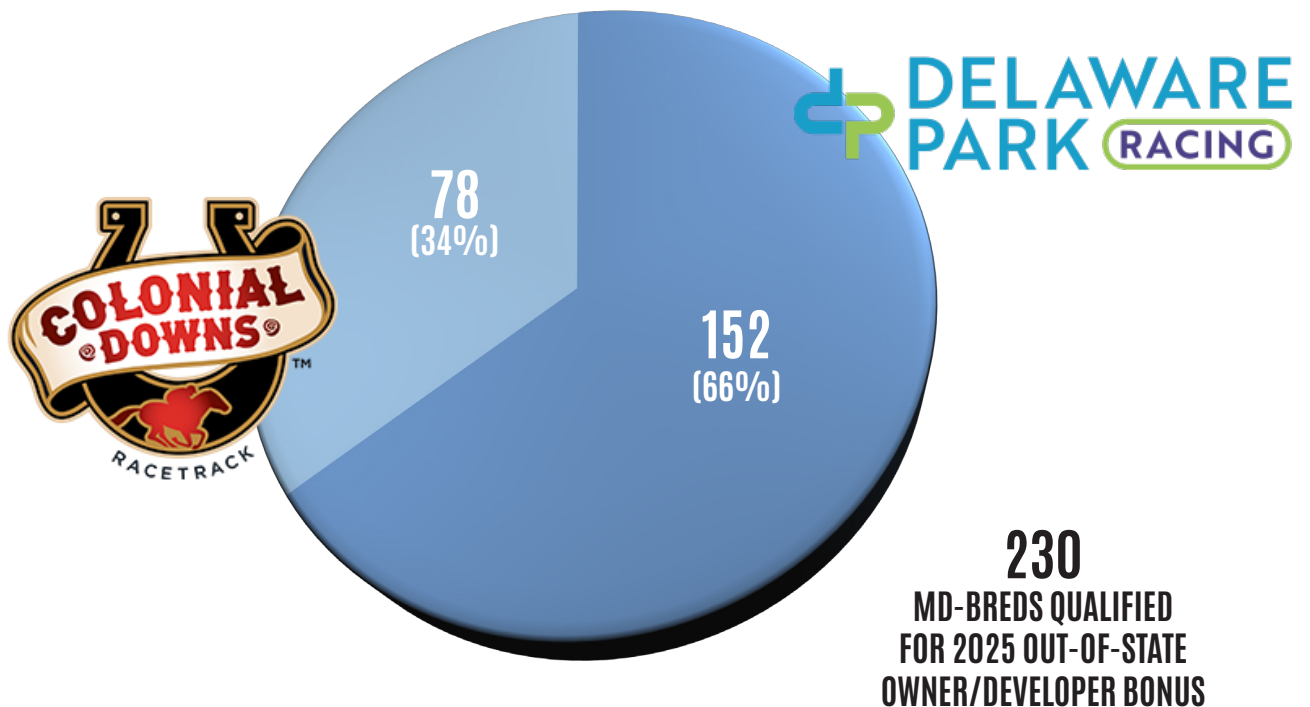

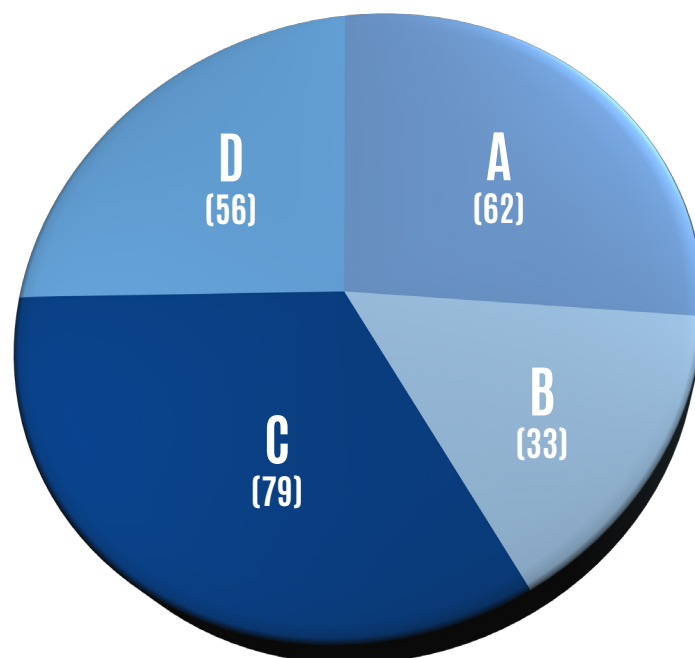

# INDUSTRY COMMITMENT TO MARYLAND-BREDS

The Maryland Thoroughbred industry has a long-standing and unwavering commitment to the promotion, support, and success of Maryland-bred horses. Central to that commitment are two key funding sources: the Maryland Thoroughbred Purse Account and the Maryland Bred Race Fund.

The Maryland Racing Commission's Maryland Bred Race Fund, administered by the Maryland Horse Breeders Association, provides breeder and stallion bonuses along with additional stakes purse supplements, to incentivize the production and racing of Maryland-bred Thoroughbreds. The Maryland Thoroughbred Purse Account not only funds competitive purses for open live racing in the state, but also invests heavily in programs that enhance the breeding, ownership, and racing of Maryland-breds—both in-state and beyond.

Together, these funds fuel a broad range of programs, including targeted incentives such as the new Out-of-State Owner and Developer Bonus Program, which rewards the development and successful racing of Maryland-breds at Delaware Park and Colonial Downs during periods when live racing in Maryland is on hiatus.

This collaborative investment ensures that Maryland-breds remain competitive, visible, and valued in an increasingly challenging national racing environment.

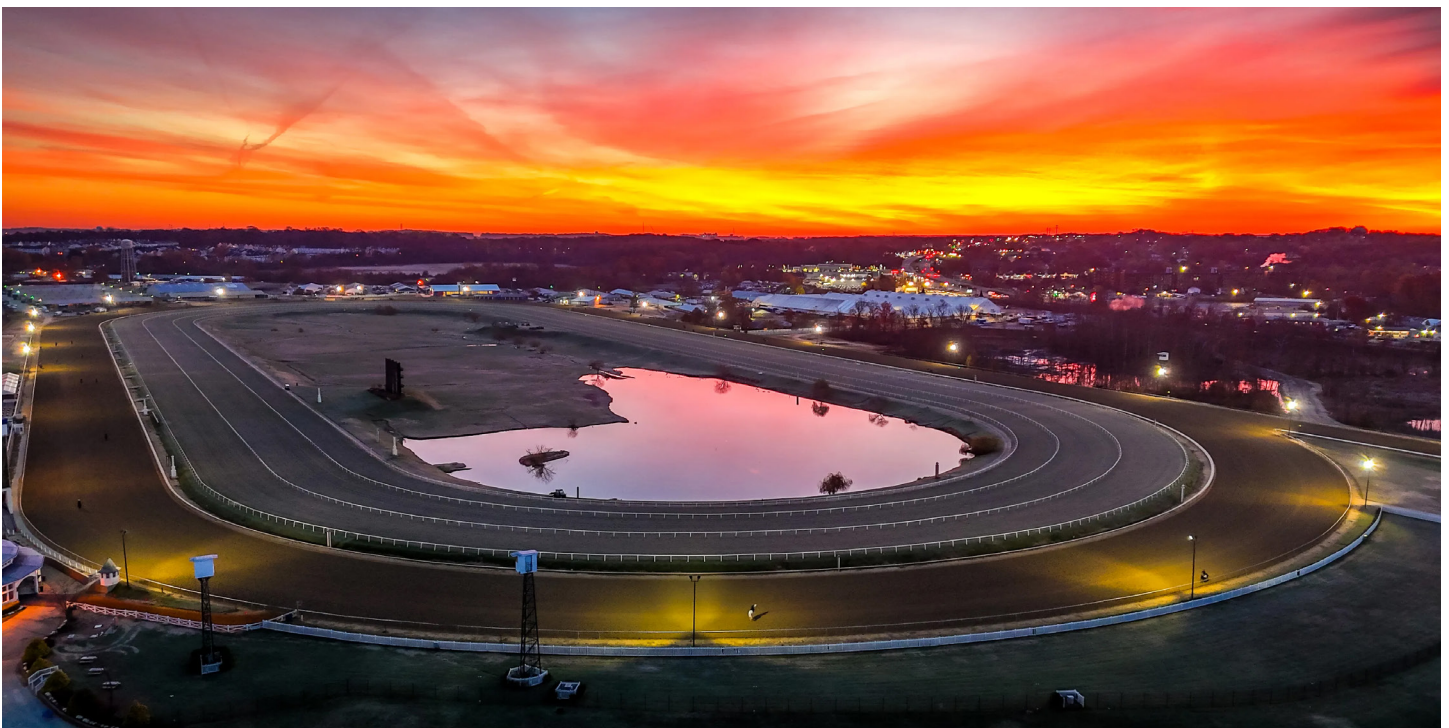

# MARYLAND THOROUGHbred PURSE ACCOUNT

The Maryland Thoroughbred Purse Account is a dedicated fund that provides purse money for Thoroughbred racing in Maryland. It is jointly administered by the Maryland Thoroughbred Horsemen's Association (MTHA) and the Maryland Jockey Club (TMJC) under a formal trust agreement approved by the Maryland Racing Commission. Funded primarily through a percentage of wagering revenue generated at Maryland racetracks, off-track betting facilities (OTBs), simulcast outlets, and Video Lottery Terminal (VLT) gaming sources authorized by the State of Maryland, the Purse Account ensures competitive purse structures to attract quality trainers and horses, support Maryland horsemen with various initiatives, and sustain both live racing and year-round stabling within the state.

In addition to funding purses for live racing in Maryland, the Purse Account supports targeted incentive and bonus programs—such as the Maryland-Bred Owner and Developer Bonus Program—that promote the breeding, ownership, and racing of Maryland-bred Thoroughbreds. It also plays a critical role in supporting the backstretch community through initiatives such as the Backstretch Pension Program, the nationally recognized Horsemen's Health System—delivered in partnership with MedStar Health—and the Jockey Injury Workers' Compensation Program, among many other diverse community initiatives, helping to ensure the well-being and long-term stability of Maryland's racing workforce.

The Purse Account further serves as a vital funding source for the Pimlico Plus plan, a transformational initiative designed to modernize Maryland's racing facilities, secure the long-term future of the Preakness Stakes, and strengthen the state's thoroughbred racing industry.
