Dear Owners, Developers, and Industry Supporters:

We are pleased to present the 2026 Report for the Maryland-Bred Out-of-State Owner/Developer Bonus Program, administered through the Maryland Thoroughbred Purse Account.

Following a successful inaugural year, the program returned in 2026 with funding increased from \$600,000 to \$700,000. The initiative rewards owners and developers of Maryland-breds competing at Colonial Downs and Delaware Park during Maryland's summer racing break, from July 3 through August 23.

Bonuses are based on points earned for first, second- and third-place finishes in eligible open overnight races. The \$700,000 fund is divided equally between Owners and Developers, with \$350,000 available to each group.

The program complements Maryland's year-round 30% Maryland-bred bonus program and provides an additional incentive to own, develop and race Maryland-bred horses.

PROGRAM DETAILS

BONUS POOL: \$700,000 (\$350,000 Owners and \$335,000 Developers).

ELIGIBILITY: Registered Maryland-bred horses finishing first, second, or third in non-restricted over-night races (excluding stakes, certified, or state-bred restricted races) at Colonial Downs and Delaware Park during the eligibility period of July 3, 2026 through August 23, 2026.

PAYOUT CALCULATION: The bonus pool will be divided by the total number of points earned across all eligible races. Each horse's bonus will be calculated based on its total points and will be equally distributed between the Owner(s) and Developer(s). The Developer is defined as the owner at the horse's first career start.

POINTS SYSTEM FOR BONUS DISTRIBUTION

Bonuses will be awarded based on a four-tiered system that assigns points based on Maryland purse equivalents:

Level	Categories	Maryland Purse	Points for 1st-2nd-3rd Place
A	No price; CLM \$50,000 & Up	\$47,000 & Up	10 pts. - 5 pts. – 2.5 pts.

C	CLM \$16,000 - \$25,000	\$26,000 - \$30,000	6 pts. – 3 pts. – 1.5 pts.
D	CLM \$5,000 - \$12,500	\$15,500 - \$24,000	4 pts. – 2 pts. – 1 pt.

- Starter Handicaps will receive points equivalent to two claiming levels higher (e.g., a \$5,000 Starter Handicap earns CLM \$12,500 points).
- No bonuses will be awarded for stakes races, certified races, or state-bred restricted races.



OUT-OF-STATE BONUS PROGRAM EXPANDS ITS REACH IN 2026

The Maryland-Bred Out-of-State Owner and Developer Bonus Program built on its successful 2025 debut with an expanded \$700,000 bonus pool in 2026. The program rewarded 150 unique owners and 140 unique developers for the performances of registered Maryland-breds at Colonial Downs and Delaware Park.

The Maryland Thoroughbred Horsemen's Association and The Maryland Jockey Club established the program to support Maryland-breds during the summer break in live racing at Laurel Park. The initiative also complemented Maryland's regional partnership with Virginia, which is designed to strengthen Thoroughbred racing in both states.

Unlike Maryland's traditional in-state Owner and Developer Bonus Program, the out-of-state initiative was not based on a percentage of purse earnings. Instead, its fixed pool was distributed through a points system tied to race conditions and comparable Maryland purse levels.

The 2026 program operated from July 3 through August 23. Registered Maryland-breds earned points for finishing first, second or third in eligible non-restricted overnight races at Colonial Downs and Delaware Park. Stakes, Certified and state-bred restricted races were excluded.

Points were awarded through a four-tier structure. Depending on the race classification, a victory was worth four, six, eight or 10 points. Second-place finishes earned two, three, four or five points, while third-place finishes earned one, 1.5, two or 2.5 points. Starter handicaps were assigned points at a level equivalent to two claiming levels higher.

The \$700,000 allocation—\$100,000 more than in 2025—was divided equally between owners and developers, creating two \$350,000 pools. A developer was defined as the owner of the horse at the time of its first career start. After all eligible results were tabulated, each point was worth \$375.94 in both pools.



DELAWARE PARK

Program records show 246 qualifying finishes during the eight-week period. Delaware Park accounted for 140, or 56%, while Colonial Downs produced 106, or 44%. The results included Maryland-bred winners across the full range of eligible conditions, from allowance and maiden special weight races to claiming and starter events. Several horses earned points more than once during the program, demonstrating sustained participation throughout the summer.

The program delivered meaningful returns across a broad group of participants. Twelve owner and developer entities—some eligible in both capacities—earned between \$10,000 and \$23,000. Another 16 earned between \$7,000 and \$9,700, while many participants received bonuses ranging from \$2,000 to \$6,700.

The out-of-state initiative complements—but remains distinct from—Maryland’s traditional Maryland-Bred Owner and Developer Bonus Program. The in-state program awards bonuses equal to 30% of purse earnings, divided evenly between owners and developers, for eligible performances at Laurel Park, the Maryland State Fair at Timonium and, upon its reopening, Pimlico Race Course.

Together, these programs reflect the Maryland Thoroughbred industry’s continuing investment in the breeding, ownership and racing of Maryland-breds. The Maryland Thoroughbred Purse Account devoted more than \$6.1 million to Maryland-bred owner and developer bonuses, allowance races and stakes in 2025, while the Maryland Bred Race Fund distributed more than \$7.4 million through breeder, stallion and out-of-state bonuses and other incentives.

The MTHA, which oversees the Maryland Thoroughbred Purse Account, thanks all the owners and developers whose participation made the second year of the summer program a success. The expanded funding and strong representation at both participating tracks helped keep Maryland-breds competitive, visible and financially supported while live racing was paused in the state.

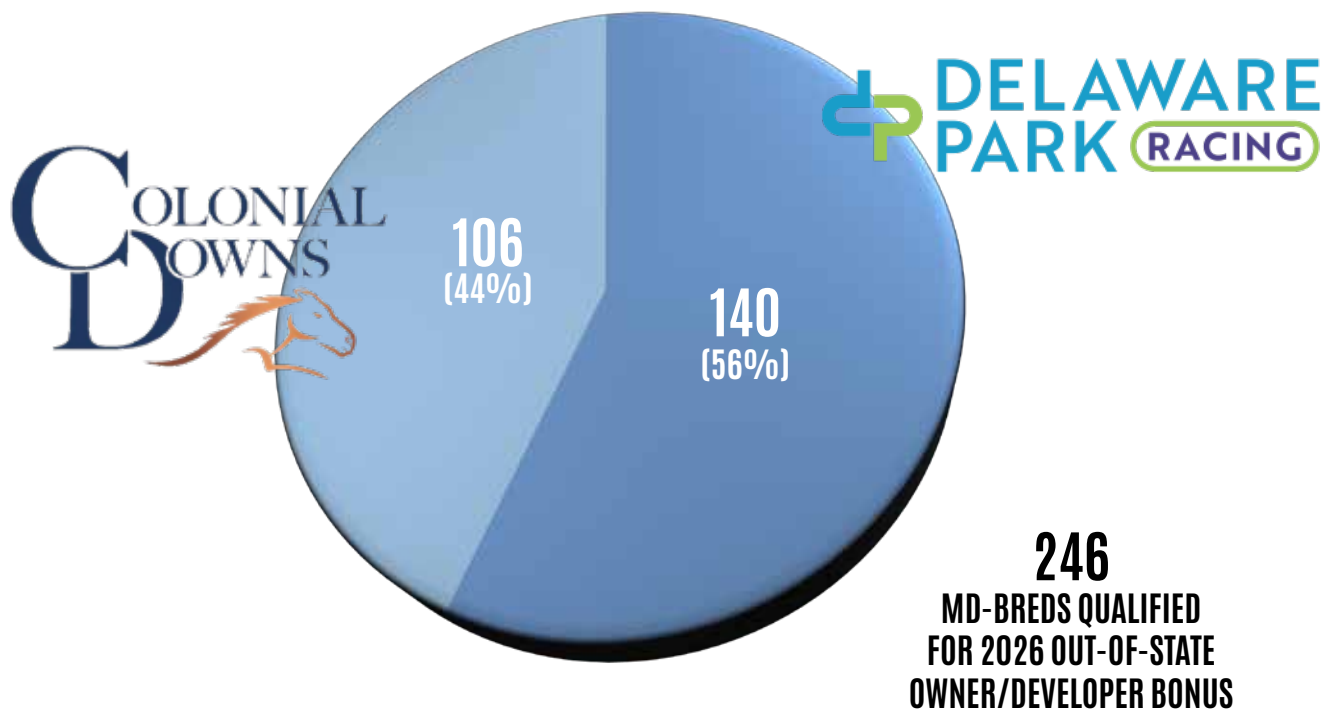

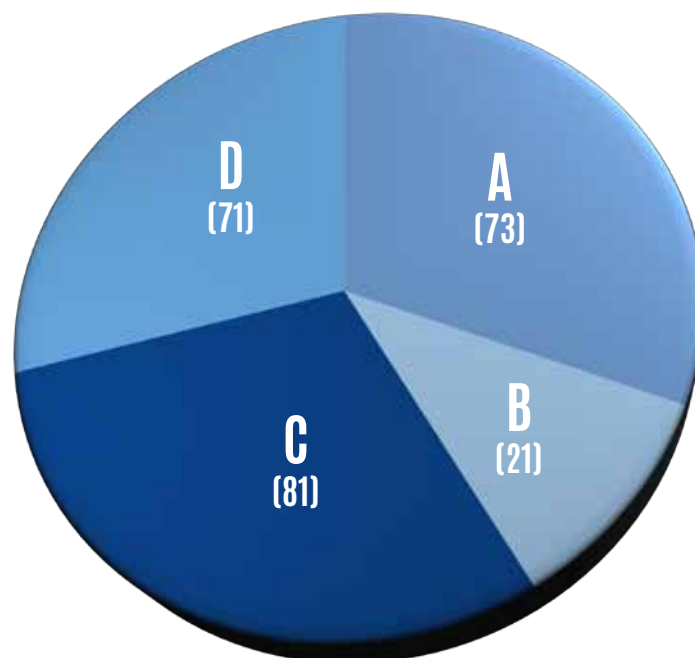

The Maryland Racing Commission's Maryland Bred Race Fund, administered by the Maryland Horse Breeders Association, provides breeder and stallion bonuses along with additional stakes purse supplements, to incentivize the production and racing of Maryland-bred Thoroughbreds. The Maryland Thoroughbred Purse Account not only funds competitive purses for open live racing in the state, but also invests heavily in programs that enhance the breeding, ownership, and racing of Maryland-breds—both in-state and beyond.

Together, these funds fuel a broad range of programs, including targeted incentives such as the new Out-of-State Owner and Developer Bonus Program, which rewards the development and successful racing of Maryland-breds at Delaware Park and Colonial Downs during periods when live racing in Maryland is on hiatus.

This collaborative investment ensures that Maryland-breds remain competitive, visible, and valued in an increasingly challenging national racing environment.

MARYLAND THOROUGHbred PURSE ACCOUNT

The Maryland Thoroughbred Purse Account is a dedicated fund that provides purse money for Thoroughbred racing in Maryland. It is jointly administered by the Maryland Thoroughbred Horsemen's Association (MTHA) and the Maryland Jockey Club (TMJC) under a formal trust agreement approved by the Maryland Racing Commission. Funded primarily through a percentage of wagering revenue generated at Maryland racetracks, off-track betting facilities (OTBs), simulcast outlets, and Video Lottery Terminal (VLT) gaming sources authorized by the State of Maryland, the Purse Account ensures competitive purse structures to attract quality trainers and horses, support Maryland horsemen with various initiatives, and sustain both live racing and year-round stabling within the state.

In addition to funding purses for live racing in Maryland, the Purse Account supports targeted incentive and bonus programs—such as the Maryland-Bred Owner and Developer Bonus Program—that promote the breeding, ownership, and racing of Maryland-bred Thoroughbreds. It also plays a critical role in supporting the backstretch community through initiatives such as the Backstretch Pension Program, the nationally recognized Horsemen's Health System—delivered in partnership with MedStar Health—and the Jockey Injury Workers' Compensation Program, among many other diverse community initiatives, helping to ensure the well-being and long-term stability of Maryland's racing workforce.

The Purse Account further serves as a vital funding source for the Pimlico Plus plan, a transformational initiative designed to modernize Maryland's racing facilities, secure the long-term future of the Preakness Stakes, and strengthen the state's thoroughbred racing industry.
