This communication is about a settlement between the Office of the Massachusetts Attorney General Andrea Joy Campbell (AGO), Uber Technologies, Inc. (Uber) and Lyft, Inc. (Lyft). We have determined that you are eligible for a payment from the settlement restitution fund. You do not need to take any further action to receive your payment.

What if I need to update or want to confirm my address?

If you want to update or confirm the address where your payment will be made, you can do so at www.UberLyftMASSAGOSettlement.com. You must update your address on the website **by August 31, 2025**. When you access the website and attempt to change your address, you will be prompted to enter this unique Access Code: <<AccessCode>> and the last 4 digits of your Social Security Number (SSN) or the last 4 digits of your Employer Identification Number (EIN).

Background

In 2020, the AGO filed a lawsuit against Uber and Lyft. On June 27, 2024, the AGO entered into a settlement agreement with Uber and Lyft that provides at least \$140 million be paid to drivers who used the Uber and Lyft Driver apps to provide rides to passengers in Massachusetts between July 14, 2020, and July 2, 2024.

Who qualifies for the settlement?

If you received this communication, we have determined that you are entitled to a payment of \$<<EstimatedAward>> from the settlement restitution fund. Specifically, some drivers who completed trips for Uber and/or Lyft between July 14, 2020 and July 2, 2024, will receive payments.

What action do I need to take?

You do not need to do anything to receive a payment. You do not need to file a claim, and you do not need to hire an attorney to assist you. You *should not* pay anybody to assist you in filing a claim or taking any action relative to this payment, and you do not need to provide any personal information (such as your bank account numbers).

The AGO has hired a settlement administrator, Rust Consulting, Inc., to send this communication and issue the payments to eligible drivers. The AGO has set the formula for how the payments will be made and the settlement administrator is making the payments based on directions from the AGO. The settlement administrator will send out all payments in approximately 60 days.

Will I have to pay taxes on the payment?

It has been determined that the payments to Lyft and Uber drivers are reimbursements of vehicle expenses the drivers incurred while driving for Lyft and Uber and the amounts of reimbursements are based on actual miles driven. Accordingly, the payments are not subject to any tax reporting or withholding. If you have any questions regarding the tax implications of your payment, please consult with your tax professional.

What if I drove for Uber or Lyft between July 14, 2020 and July 2, 2024, but did not receive a letter from Rust?

Not all drivers are eligible for a settlement payment. Only drivers who drove more than casually are eligible for payment. In addition, some drivers whose pay far exceeded the minimum wage after expenses are not eligible or will receive a lower reimbursement rate than drivers who were paid less. If you did not receive this letter and have moved or changed your email address since you last drove for Uber or Lyft, you may contact Rust Consulting at (888) 562-1052 to get more information.
