RE: NOTICE OF DATA BREACH

Highlands Oncology Group PA ("Highlands") values and respects the privacy of your information, which is why we are writing to advise you of an incident that may have involved some of your personal information. We have no evidence that your information has been misused for the purpose of committing fraud or identity theft. Nonetheless, we want to make you aware of the incident and the steps we have taken to address it.

What Happened? On June 2, 2025, we discovered we were the victim of a cyber-attack and certain Highlands files and systems were inaccessible. Upon discovering the incident, we promptly began an internal investigation, worked to secure our systems, and notified law enforcement. We also engaged a forensic security firm to assist with our investigation and ensure the security of our computer network. The forensic investigation determined that an unauthorized third party accessed our computer network at times between January 21, 2025, and June 2, 2025, and encrypted some of our files. The investigation also determined that the third party may have accessed and acquired certain files from our systems during this period.

What Information Was Involved? Based on the results of our investigation, we analyzed the affected files to identify individuals whose information may have been accessed or acquired without authorization during the incident. We have since determined that the files may have contained some of your personal information, including your <

Elements>><<Variable Data 1>>, to the extent contained in our computer systems.

What We Are Doing. In addition to the actions described above, we are taking further steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Also, although we have no evidence that information potentially involved in this incident has been used for identity theft or fraud, we have arranged for you to enroll in a one-year membership of Experian IdentityWorksSM Credit 3B, if you would like to do so. This product helps enrollees detect possible misuse of their personal information and provides identity protection services focused on prompt identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you. For more information, including instructions on how to activate your complimentary membership, please refer to the additional information enclosed.

What You Can Do. You can take advantage of the complimentary credit monitoring included in this letter. You can also find more information on steps to protect yourself against possible identity theft or fraud in the enclosed *Additional Important Information* sheet.

<u>Fraud Alerts</u>: By law, you have the right to place a fraud alert on your credit report if you believe you have been, or are about to become, a victim of fraud or related crime. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. <u>Credit and Security Freezes</u>: By law, you have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
