CLARIFICATION ON NEWS STATEMENT

The Board of Directors (the “**Board**”) of ProsperCap Corporation Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) refers to the news statement, “Prospercap Corporation Says Unit Issued New 6 Bln Baht Promissory Note To Bangkok Bank” (the “**News Statement**”), which was disseminated by Reuters at approximately 18:17 GMT+8 on 28 January 2026.

The Board would like to clarify that the News Statement is misleading in that the Company did not issue any new promissory note in favour of Bangkok Bank, as stated.

The Company would instead refer shareholders to the announcement of the Company made on 28 January 2026 via SGXNet titled “**DISCLOSURE PURSUANT TO RULE 728 OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED LISTING MANUAL SECTION B: RULES OF CATALIST (“CATALIST RULES”)**”, where it was disclosed that DTGO Corporation Limited (“**DTGO**”), an indirect controlling shareholder of the Company, and Bangkok Bank Public Company Limited (“**BBL**”) had entered into a new THB 6,000,000,000 promissory note sale agreement dated 27 January 2026 and DTGO had issued a new THB 6,000,000,000 promissory note to BBL on 27 January 2026.

The Company has reached out to Reuters to highlight the misinformation.

Should there be any matters requiring disclosure, the Company will make the necessary announcement via SGXNet in accordance with its obligations under applicable rules of the Catalist of the Singapore Exchange Securities Trading Limited.

Shareholders and potential investors are advised to exercise caution in their review of any media reports relating to or involving the Company ahead of any definitive announcement by the Company when dealing with the Company’s securities.
