Resolution to hold a Public Hearing to hear comments from the public on a Local Law to override the tax levy limit established in General Municipal Law §3-c on November 5, 2025 at the Town Hall at 7:40pm.

Resolution to hold a Public Hearing to hear comments from the public on the town's 2026 Preliminary Budget on November 5, 2025 at the Town Hall at 8:00 pm.

Resolution to hold public hearing on November 5, 2025, 8:20 pm, For Public comments on Town of Darien's current Community Development Block Grant project: 306PR139-23 Force Main Sewer construction.
