



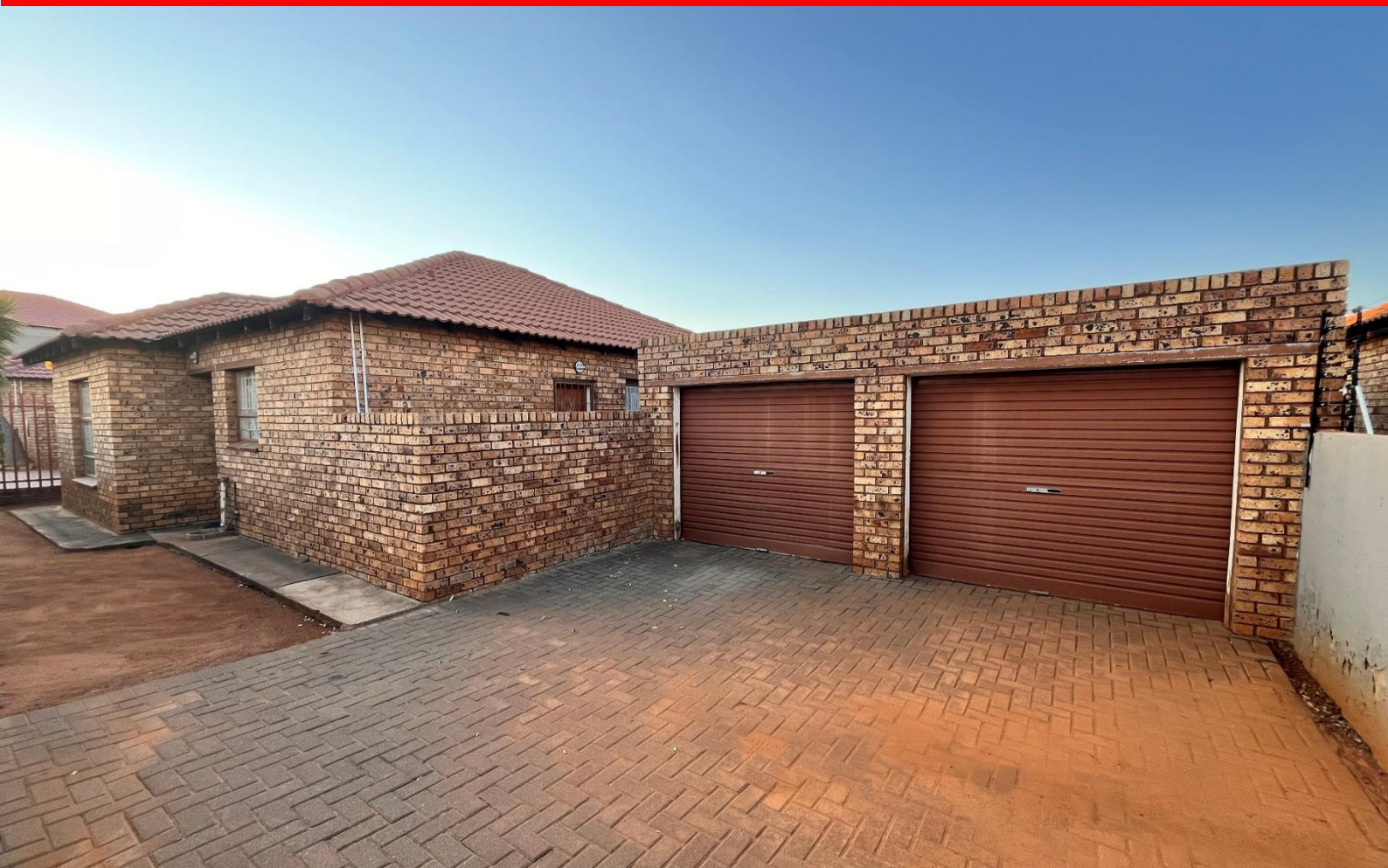

GUIDELINE OF THE AUCTION

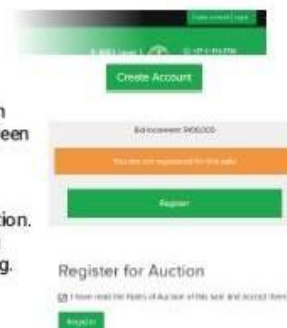
