- **A.** Residential Land Sale In 2013, the authority purchased a residential tract of land on the corner of Bishop and 14<sup>th</sup> from the City of Lawton for 4500.00 We have received an offer of 14,000.00 from a client of Johnny Owens. Since there are no future plans for that land it is the Directors recommendation to sell.
