



View of the yoke on the transfer case.





Install bolts must use thread locker.

Use the OE O-Ring seal.


Retighten all driveline bolts after the first 100 miles and every 3000 miles there after.


FRONT SHAFT







REAR SHAFT









After the JEEP is lifted, the front and rear inclination angle of the axle kingpin changes, which causes the vertical angle of the drive shaft to be too large. Maximum working angle is 20° .




Adjustment method: Adjust by replacing the adjustable control arm (A,B) to make the axle inclination angle within the proper range.





Adjustment method: Adjust by replacing the adjustable track bar(C), and adjust the left and right track to be consistent.
