

# BNF Students Package 2026 Campaign Prize Draw Terms and Conditions ("Terms and Conditions")

BNF Customers benefiting from the BNF Students Package may be eligible to participate in a prize draw to win Vouchers from a Retail Outlet worth up to a combined Five Hundred Euro (€500.00) ("the Prize Draw").

## 1. Definitions

'BNF' refers to BNF Bank p.l.c.

'Account' refers to the BNF Student Current Account in the name of the Account Holder.

'Account Holder' means the person/s listed or identified as the holder/s of the Account.

'Prize' means the voucher granted by the Bank to the Prize Draw winner, in accordance with these terms and conditions.

'Prize Draw' means the promotional draw through which a winner is randomly selected in accordance with these Terms and Conditions.

'Prize Draw Period' means Accounts successfully opened with the Bank between and including 1<sup>st</sup> June 2026 and 31<sup>st</sup> October 2026.

## 2. Eligibility

- 2.1 Only Account Holders that have attained sixteen (16) years of age by the date of the Prize Draw

## 3. Prize

- 3.1 Vouchers worth up to a combined Five Hundred Euro (€500.00) will be awarded to five (5) winners. The voucher will be issued from a retail outlet, which shall be determined at the Bank's discretion.

- 3.2 There will be a total of five (5) winners selected via a ballot process, in the following order of selection and prize allocation:

- i. The five (5) selected winners will each receive a Voucher valued at One hundred Euro (€100)

- 3.3 All vouchers shall be subject to the outlet's own Terms and Conditions of use. The Bank is not responsible for any restrictions, limitations, or conditions imposed by the outlet in relation to the redemption or use of the vouchers.

- 3.4 The Prize is non-transferable and non-negotiable. No cash or credit alternative will be offered. In the event that the prize is unavailable due to any reason, the Bank reserves the right to offer an alternative prize/s of equal value. The Bank will not be

liable for any loss, damage, liabilities or disappointment arising from the delivery or use of the product offered through this Prize Draw.

- 3.5 If after reasonable efforts by the Bank, the prize is unclaimed, declined or it is not possible to contact the winner, at the Bank's absolute discretion, the Bank reserves the right to retract the prize from the winner that the Bank has not been able to contact and redraw a new winner from the other entries registered in the Prize Draw Period. If an entry is invalid or in breach of these Terms and Conditions, then the winner's prize will be forfeited, and the Bank will be entitled to redraw another winner. The Bank shall not be held responsible for the inability of a winner to take advantage of the prize for any reason.
- 3.6 The winners will be notified by on the day of the draw or following day using a recorded telephone line.
- 3.7 The winners of the prizes have two days to confirm acceptance of the Prize or otherwise.
- 3.8 Confirmation of the acceptance of the Prize can be done at one of the Bank's branches or by using the Banks Internet Banking secured message.
- 3.9 The Bank will notify the winner when they can collect the Prize. A photo-op will be organised and the photo will be posted on our social media channels.

- 4.1 We will hold monthly draws to determine the Prize winner. The Prize Draws will be in the following order:

  - 31st August 2026 for a one-hundred-euro (€100) Eurosport voucher,
  - 30<sup>th</sup> September 2026 for a one-hundred-euro (€100) Eurosport voucher,
  - 30<sup>th</sup> October 2026 for for a one-hundred-euro (€100) Eurosport voucher
  - 30<sup>th</sup> November 2026 for the final one-hundred-euro (€100) Eurosport voucher.

The winner will be drawn at random by a manual draw under the supervision of an independent person within the Bank. Our decision is final, and no correspondence will be entered into regarding the prizes once the winner has been drawn.
