



# **Juvenile Justice Programs**

### **Juvenile Diversion Alternative Program**

(JDAP) is a pre or post arrest diversion program that provides services based on individual youth and family needs. Only youth referred by the Department of Juvenile Justice (DJJ) and approved by the State Attorney's Office (SAO) in, the judicial circuit in which services are to be provided, shall be admitted to JDAP. JDAP is a strength-based model built on the principles of risk and responsivity. The team starts by assessing the needs of the youth admitted into the program and then tailoring an individualized service plan to reduce the risk of recidivism.

Average Length of Stay: 120 days

### **Community Supervision Program**

BAYS works with children being detained under home detention, intensive home detention with electronic monitoring in this program do not commit any new delinquency offenses and remain compliant with the court's detention order. Our Specialists perform random compliance checks with youth, collaborate with local law enforcement agencies and DJJ, and work to reduce failure to appear rates.

Average Length of Stay: 26 days

### **Youth Screening Program**

BAYS Youth Screening Program provides detention screening services at either a local Juvenile Assessment Center or Juvenile Detention Center. When a youth is taken into custody by law enforcement, detention screening staff are available to conduct a number of assessments to determine if the youth will remain in their community or be placed in secure care while pending their next court hearing. In addition, the screening staff complete substance abuse and mental health assessments and refer youth and families out for additional services.

# Behavioral Health Programs

### **BAYS Family Connections**

BAYS is proud to be a provider of Functional Family Therapy through BFC. Functional Family Therapy (FFT) is a short-term, high-quality intervention program with an average of 12 to 14 sessions over three to five months. FFT works primarily with 11- to 18-year-old youth who have been referred for behavioral or emotional problems by the juvenile justice, mental health, school, or child welfare systems. Services are conducted in both clinic and home settings, and can also be provided in schools, child welfare facilities, probation and parole offices/aftercare systems, and mental health facilities.

Average Length of Stay: 117 days

#### **STRIVE**

Through intensive, in-home services, BAYS will provide overlay services to children and families who are involved, or at risk of becoming involved in the child welfare or delinquency systems. Services are designed to partner with the family and implement preventive measures to strengthen and stabilize the family.

Average Length of Stay: 101 days
