All fees are payable in Ringgit Malaysia (RM). The stipulated stamp duty fee is collected in accordance with, and is governed by, the Malaysian Stamp Act 1949. Any amendments to the Act shall be notified in due course. A complimentary single-size bedding set will be provided (pillow, pillowcase, duvet, duvet cover, bed sheet and mattress protector). Residents are required to bring their own towels, toilet linens, toiletries, cooking utensils and cutlery. Cooking is allowed in all unit types. All residents are expected to maintain the cleanliness of their respective rooms, units and common areas.									

Conditions of Reservation

- Only registered Taylor's University or Taylor's College students may apply for accommodation with Taylor's Hostel Management.
- All successful applicants are required to fulfil an initial one-year tenancy agreement.
- Applicants may submit this application form and await official written notification from Taylor's Hostel Management regarding room availability, as submission does not guarantee confirmation of the desired room type at the selected location. Upon receiving a room offer, applicants are required to pay a RM500 non-refundable application fee and a RM3,000 deposit to secure the room. Once payment is made, the RM500 application fee is non-refundable in the event of cancellation.
- Upon confirmation of room offer, tenants are required to sign a tenancy agreement. Under the Malaysian Stamp Act 1949, the responsibility for paying stamp duty lies with the tenant. The applicable stamp duty amount will be collected together with the rental payment.
- The tenant shall be solely responsible for the payment of all applicable stamp duties on any and all documents related to the rental of beds. This includes, but is not limited to, the application form, room offer letter, tenancy agreement, and room change form. Taylor's Hostel Management reserves the right to recover any such costs from the tenant.■
- The deposit is refundable upon the following conditions:
 - The applicant cancels the room booking with written notice a minimum of one (1) month **before** the PROGRAMME COMMENCEMENT DATE, **OR**
 - The applicant fulfils the initial **one-year** tenancy agreement, and subsequent renewed tenancy (if any).
- Should the applicant fail to check-in after the PROGRAMME COMMENCEMENT DATE, no refund will be given for all payments made and the room reservation will be released immediately without further notice.
- Applicants are required to pay six (6) months advance rental prior to check-in. Thereafter, rental must be paid every six (6) months in advance.
- Rental rates are subject to change. Taylor's Hostel Management will do its best to inform all affected residents. Any other charges including, but not limited to, utilities and penalties will be imposed at the discretion of Taylor's Hostel Management.
- Based on check-in date, the following shall apply:-
 - From 1st to 15th of the month - full month rental
 - From 16th to 31st of the month - half month rental
- Rental rates exclude utilities charges, which will be billed monthly based on meter readings.
- Rooms are allocated on first-come-first-serve basis at the discretion of Taylor's Hostel Management. All reservations made are not transferable.
- All refunds (subject to fulfillment of stipulated terms and conditions) must be claimed by the applicant or the applicant's parent/guardian/next of kin within one (1) year from the check-out date. If not claimed within the stipulated time, it is deemed that the Applicant agrees to donate the amount to Taylor's for refurbishment, upkeep, improvement and/or maintenance purposes.
- Taylor's Hostel Management reserves the right to proceed with any and all refurbishment, improvement, inspection and/or maintenance works in all units and rooms as and when necessary. Residents may not deny any staff/appointed contractor entry into any and all units and rooms.
- Taylor's Hostel Management reserves the right to change/amend any of the conditions stated above where necessary without prior notice.

Declaration

- I understand and accept the above Conditions of Reservation, and undertake to make payment of all sums due in a timely manner if my application is successful.
- I declare that the particulars in this application form are true to the best of my knowledge, and I have not willfully suppressed any material fact.
