- (i) I have read the Prospectus/Diary and shall abide by the rules as stated therein or laid down by the school authorities from time to time.
- (ii) The school fee must be paid by 10th of every month. Late fee charges will be applied according to the dates of payment delay. If the dues are not cleared by the end of the next month, the name of the student will be struck off the rolls, and Re-Admission fee will be charged. If payment is made by cheque and it bounces, the parent will be responsible for any legal action that may follow. Any bank charges will also be borne by the parent
- (iii) Yellow card will be issued for violating school rules and regulations, being absent without permission, improper uniform, non-payment of fee, incomplete homework, misbehaviour, foul language and damaging school property

Note: If a student receives three yellow cards, his/her name will be struck off from the school rolls. Admission charges will be applicable, if the child is admissible for Re-Admission.

I understand and agree that :

- (a) The decision of the Principal shall be final and binding.
- (b) The information given by me is correct to the best of my knowledge and nothing has been withheld or concealed. In case of any wrong information, my ward will be expelled.
- (c) My ward will be expelled in case of any indiscipline on his/her part.
- (d) Fees once deposited, by day scholars or boarders, will not be refunded.
- (e) In case of withdrawal of my ward from the school (day scholar/boarder), only the security amount will be refundable.
- (f) In case of expulsion of my ward on the ground of damaging the school property or non-payment of dues, the security amount will be forfeited.
- (g) I will not be allowed to change the status of my ward from a boarder to a day scholar during mid session.
- (h) School reserves the right to change the school uniform as and when required, but it will be in the beginning of the session.
- (i) Any taxes on the facilities availed to the students, levied by the Govt., will be borne by me.
- (j) The grant of scholarships/fee concessions and the withdrawal of the same at any time, is the sole authority of the Management.
- (k) All disputes will be settled within the jurisdiction of courts at Karnal.

N.B. : FOR CLASS XI ONLY

The admission to class XI is provisional, notwithstanding anything to the contrary in the Prospectus/Diary. The admission of the student stands cancelled from the school in case he/she fails in class X examination even if he/she has paid the fees and attended or not attended the classes. Only the security amount will be refunded. This is applicable to both day scholars as well as boarders. I understand that my child admission to class X/XII is purely provision subject to approval by Central Board of Secondary Education. The decision of the C.B.S.E. in this matter shall be whole heartedly acceptable to me and the school will not be liable in case of rejection of my child's case by the C.B.S.E.
