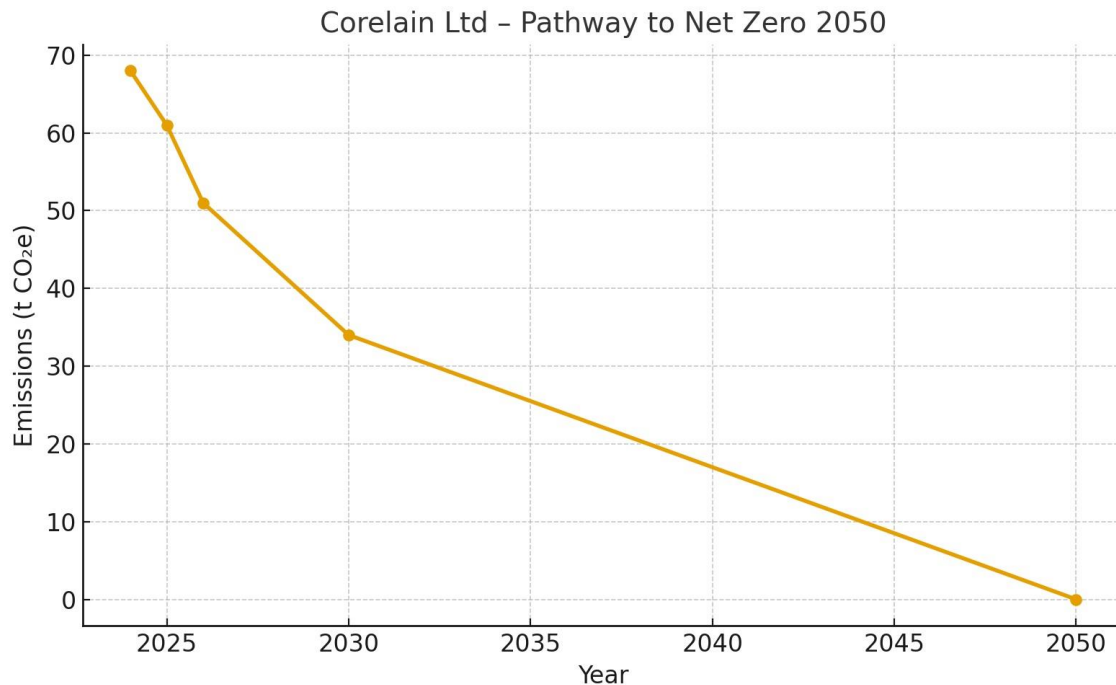


Figure 1: Corelain Ltd – Pathway to Net Zero 2050

We project that total emissions will fall to approximately 34 t CO₂e by 2030, representing a 50 % reduction from the FY 2024/25 baseline.

Progress against these targets can be seen in the graph below:

Completed and Planned Carbon-Reduction Initiatives

Corelain has already implemented, or is implementing, the following initiatives:

- Hybrid-working policy reducing commuting emissions by 40 %;
- Low-power office settings and energy awareness campaign;
- Supplier ESG engagement and spend-based carbon analysis;
- Transition plan to electric vehicles by 2027;
- Adoption of virtual-first meetings to cut travel emissions.

Future measures will include a renewable-energy tariff, Cycle-to-Work scheme, and annual carbon data assurance by an external verifier.
