AltHub Terms and Conditions

- 1. Grant of License: Neudata ("Licensor"), through its partner Althub ("Partner"), grants to Customer a non-exclusive, non-transferable license to use the Licensor Products and/or services described herein (the "Product") in the manner and for the purposes permitted in this Exhibit ("Exhibit"). Customer may not: (i) sublicense, publish, transmit, transfer, sell, reproduce, distribute, alter the Product; or (ii) charge a licensing or similar fee for providing any portion of the Product to any third party without Licensor approval.
- 2. License: Product delivery will be made by the Licensor providing end-user licenses to the Customer. The Licensor shall use commercially reasonable efforts to maintain the timeliness of access to the platform.
- 3. Access rights: If QuantLab or Fundamental Edge modules are used a) Customer will be able to access its profile as well as portfolios built based on their data on the platform and b) Customers with an enterprise license will also be able to upload new datasets and create investment portfolios on their own.
- 4. Data Protection: The platform does not display any underlying raw data and hence no user of the platform can see or access the Customer input data on the platform. If the Customer's data is raw, only the signals generated by the platform are stored in its secured cloud environment. If the platform is used for Customer data delivery, the underlying raw data is stored in a separate cloud location. Portfolios built for the Customer are by default private and visible only to the Customer on the platform. However, they can be made public portfolios to be visible to all users if the Customer chooses.
- 5. Data Transfer: Data can be sent to the platform in excel/csv formats into's AWS S3 location or FTP folders or Dropbox or any other shared drives. Customer is solely responsible for the ownership and accuracy of the data.
- 6. Ownership: Partner retains all right, title and interest in: (i) the Product, as well as in any enhancements or modifications thereto and (ii) any Partner marks. Partner holds all rights to its data including improvements. For Symlink data output for LSEG RIC and MSCI ISIN codes, the Customer can use only while an active agreement is in place. If this Exhibit is terminated, this specific data must be purged or Customer obtains appropriate agreements with these two organizations to keep.
- 7. Service Support. Partner will make commercially reasonable efforts to (a) ensure that the Product is free of viruses and damaging or disabling code, errors or other defects and (b) correct any such errors or defects that are correctable within a reasonable amount of time. Partner will provide support for the Product.
