'Keeping Well in Community Care Navigation/Care Coordination' Megan Newman, Clinical Nurse Specialist Primary and Community Health, SWS Local Health District Aim: empower patients at home and in the community via telehealth Health education Ongoing individualised support Who is supported? At high risk of hospital admission Frequently presenting to ED Discharged from hospital without enough support at home Facing mental health, social or economic challenges SWS residents Outcomes Less hospital admission and length of stay Improved health literacy Increased confidence and ability to self-manage Care Navigation and Care Coordination 12 + clinicians Guiding them to the right services at the right time – specialists and community programs, assist in accessing transport, referrals to appropriate services, low cost or free food, bulk billing GP's

Sharing consistent care plans with specialists and relevant stakeholders providing care Closing gaps – no one is left out of the loop Who we work with: Chronic health conditions: complex or ongoing o Psychosocial challenges: Mental health challenges, isolation, lack of supports o Socio-economic barriers: low income, limited education o Cognitive & Intellectual Needs: low health literacy, language barriers Carer needs: Preventing carer burnout connecting with respite and support Exclusions include under the age of 16, not living in SWS. 12-week program – minimum of 5 telehealth calls with clinician, Call 1: Assessment Calls 2 & 3: Monitoring Call 4 (week 8): Monitoring Call 5 (Week 12): Re-assessment o additional calls as needed based on patient's circumstances, home visits available if required Keeping Well in Community flyer For more information (including video): https://www.swslhd.health.nsw.gov.au/communityhealth/CNCC.html **Guest Speaker:** 'Seniors Rights Service Overview and Emerging Issues in Advocacy' Anne Dixon, Team Leader Community Development Seniors Rights Service Advocacy Services: intake call centre at Surry Hills who then refer on to appropriate regional advocate. Provides support in NSW for recipients of all Commonwealth funded aged care services. Specialist financial advocates – Example of when a senior was supported identified overcharging via a request to assist in understanding financial statement from HCP provider. Financial advocate was able to work with HCP to resolve (with consent from older person). Generalist Legal Advice: e.g. documents for guardianship and power of attorney 6.
