A secure method of communication between Perspectief and your employee

Why MijnPerspectief?



Your employee can hold online consultations with the company doctor or other health professionals.



Your employee can download the documentation they need for the Employee Insurance Agency (UWV) themselves in the case of a long-term absence.



Your employee can quickly and easily sign an online authorisation for medical information requests.



Communication is privacy-proof as we use two factor authentication.



Your employee always has insight into upcoming appointments and who the point of contact is.



Reports from the company doctor and other health professionals always reach your employee securely.



The retention period for documents and data is set automatically.

MijnPerspectief is a highly secure Perspectief environment that gives your employees access to their personal absence from work file. MijnPerspectief forms part of our standard service. We share reports, feedback and information from our professionals directly with your employees via MijnPerspectief. In addition, we send invitations for appointments with the company doctor or other health professionals and request medical information via MijnPerspectief.

How does MijnPerspectief work?

When the need arises, your employee will receive a personal email at the address known to us asking them to create an account for MijnPerspectief. If the employee already has an account, they will receive an email telling them that there is a new message for them in MijnPerspectief. It's also possible to invite an employee to use MijnPerspectief when they commence employment. They will then only receive an email telling them that there is a new message for them when the need arises.

Why MijnPerspectief?

We work with sensitive employee information and naturally want to avoid it getting into the wrong hands. We may only communicate directly with the employee about their medical information. Under privacy guidelines, this information may not end up in a different environment, such as your HR system. Using email brings with it a high risk of data leaks. We can pass on information to your employees securely via MijnPerspectief. This is partly because we use two factor authentication, but also because we have control over the information that we share with your employees via MijnPerspectief. If incorrect information is provided for whatever reason, we can subsequently withdraw this information ourselves. The only thing we share with you is any work-related adjustments and/or recommendations. We do this via a link to your HR system or via your separate CAMAS environment (employer portal).

Other advantages of MijnPerspectief

- Reports from the company doctor or other health professionals always reach your employees securely.
- Your employees always have insight into upcoming appointments and who the point of contact is.
- Employees who are absent from work in the long term can download the documentation they need for the Employee Insurance Agency (UWV) themselves. This saves your HR personnel having to do this (and therefore time).
- Your employees can hold an online consultation with the company doctor or other health professionals.
- Requests for medical information are much easier and quicker as your employees can sign an online authorisation. This eliminates the need for sending the documents by post. Moreover, a QR code on the authorisation and medical information enables us to link the information to the correct file straight away.
- The retention period for documents and data is set automatically. This includes the deletion of personal data (two years after termination of employment) or financial information (seven years after termination of employment).

Dynamic questionnaires

We use MijnPerspectief for questionnaires as well. These are short questionnaires that your employee completes shortly after you have reported them sick for work. These offer us insight into your employee's situation/absence from work and enable us to give them advice tailored specifically to their situation.
