Textual Information(1)	<p>The Board of Directors of Nazara Technologies Limited (the Company), by way of a resolution passed through circulation on June 16, 2025, approved the allotment of 50,00,000 (Fifty Lakhs) fully paid-up Equity Shares of face value Rs. 4/- (Rupees Four Only) each, at a price of Rs. 990/- (including a premium of Rs. 986/-) per share, on a preferential basis by way of private placement to Axana Estates LLP (the Allottee) for an aggregate consideration of Rs. 4,95,00,00,000/-. This Preferential Issue triggered an obligation to make an open offer in accordance with Regulation 3(1) and Regulation 4 of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (SEBI SAST Regulations). The open offer, made by Axana Estates LLP (Acquirer 1), Plutus Wealth Management LLP (Acquirer 2) (together referred to as Acquirers) along with Junomoneta Finsol Private Limited being Person Acting in Concert (PAC), concluded on July 07, 2025, i.e, after the closure of reporting quarter ended June 30, 2025. Following the completion of the open offer, the Allottee (i.e. Acquirer 1), and Acquirer 2 have become promoters of the Company along with existing promoters. Furthermore, PAC, Mr. Arpit Khandelwal, Mr. Mithun Padam Sacheti and Mr. Siddhartha Sacheti being deemed persons acting in concert (Deemed PAC) have been classified under Promoter Group of the Company pursuant to the said open offer. Therefore, the shareholdings of Acquirers, PAC and Deemed PAC are currently reflected under the Public category in the Shareholding Pattern for the quarter ended June 30, 2025.</p>
