

Entry Policy

1. Age Restriction

- **Strictly 18+ only.**

All guests must provide **valid, physical photo ID** to gain entry. Accepted forms of ID include:

- UK Passport
- UK Driving Licence (Provisional or Full)
- EU/International passport

Photos or copies of ID will not be accepted.

2. Re-entry

All entry fees are for a one time entry only. If you leave the venue and return later, you will be required to re-pay entry. We have a designated smoking area on site.

3. Dress Code

We operate a **smart-casual dress code**. The following are **not permitted**:

- Sportswear (e.g. football shirts, tracksuits)
- Flip flops/sliders
- Soiled or excessively torn clothing
- Offensive slogans or images on clothing
- Caps or hoods (Must be off at all times)

Management reserves the right to refuse entry based on appearance.

4. Search Policy

For the safety of staff and guests, **bag searches and personal searches** may be conducted by licensed security personnel.

- **Zero tolerance** for weapons, drugs, or any illegal substances.
 - Any illegal items found will be confiscated and the police will be notified.

5. Right to Refuse Entry

Entry is at the discretion of the door staff and management. We reserve the right to refuse entry or eject individuals based on:

- Intoxication
- Aggressive, threatening, or antisocial behaviour
- Previous bans from the venue
- Breach of any entry policy

No refunds will be given if entry is refused due to breach of policy.

Medbar is a private licensed venue, management and security have the right to refuse entry or remove any persons for any reason without reason.

Right of admission is required. This means we give you the right to enter the venue, you do not have the right to enter without our permission.

6. Ticketed Events

- A valid ticket guarantees **entry consideration**, not automatic entry.
 - All other entry conditions must still be met (e.g. ID, dress code, behaviour).

7. Group Bookings / Stag & Hen Parties

- Group entries may be monitored more closely.
 - We reserve the right to split or stagger entry for large groups.
 - Fancy dress is permitted at management discretion—contact us in advance for approval.

8. Accessibility

Accessible entry and facilities are available on our ground floor. If you have any concerns please contact us in advance for any accessibility needs so we can assist you appropriately.

9. Code of Conduct

We are committed to providing a safe and respectful environment. Discrimination, harassment, or hate speech of any kind will result in immediate removal and potential banning.

10. CCTV & Surveillance

CCTV is in operation throughout the venue for the safety of our patrons and staff. Footage may be used as evidence in case of an incident.

11. Outside liquids

For health and safety reasons, no outside liquids including water bottles are allowed in the venue.
