

Consent to the production, processing, and publication of photo and video recordings

In the course of the Porsche Tennis Grand Prix 2025, Dr. Ing. h.c. F. Porsche AG (“**Porsche**”) wishes to produce photo and/or video (film and sound) recordings (“**recordings**”) of you in the and to use such for documentation and reporting purposes.

The production, processing, and publication of the recordings and the personal data contained therein shall be effected on the basis of this voluntary consent declaration.

The consent can be revoked for the future – also in part (e.g., pertaining to only one particular photograph) – by respective declaration provided to Porsche; no reasons have to be provided in such case. The recordings will then be deleted or edited within a reasonable period in such a manner that no further identification is possible. Analog media already produced shall be used up insofar as removal or editing is not required by a respective legitimate interest in the individual case.

Porsche advises that a publication on the Internet transcends national boundaries and that it cannot be ensured that all recordings – e.g. in event of a revoked consent – can be removed without a trace. Additionally, in the event of a publication on the Internet, the recordings can be found using search engines.

I CONSENT to having Porsche itself, or through its designees, produce photo and/or video recordings of my person in the course of the Porsche Tennis Grand Prix 2025 and then processing them as follows:

- Permanent storage for the purposes listed below on internal servers of Porsche as well as on servers of instructed third parties.
- Creation and dissemination of documentation to sponsors and partners of the Porsche Tennis Grand Prix.
- Dissemination in internal media of Porsche, such as Intranet, Carrera magazine and Carrera site newspaper, as well as utilization for internal presentations.
- Publication on www.porsche-tennis.com as well as on Porsche social media channels and the social media channels of sponsors on the following platforms: Facebook, Twitter, Instagram, Youtube, and LinkedIn.
- Publication in analogue media covering the Porsche Tennis Grand Prix, for example tournament magazine, Daily News, and yearbook, as well as publication in the Porsche customer magazine.
- Publication on Porsche PR channels, for example Porsche Press Database and Porsche Newsroom, as well as dissemination to external media.

To the extent that any indications as to my ethnic background, religion, or health (e.g. skin colour, head covering, eyeglasses) appear from the recordings, my consent shall also pertain to these details.

The recordings may be edited or redesigned, considering my rights of personality (e.g., by montage, combinations with pictures, texts, or graphics, photo-technical defamiliarization).

In addition, I declare that I waive any compensation claims for the production and the aforementioned types of use of the recordings, as well as any claims for using the recordings for my own purposes or to exploit such in any other manner.

This consent declaration shall be subject to the law of the Federal Republic of Germany.
