This Privacy Notice ("**Notice**") explains how we collect, use, disclose, and store personal data, including data related to our blockchain and securities tokenization services.

This Notice only applies when Nomyx is the Controller of personal data (example: Nomyx website visitors' personal data, business-to-business contact data, and investor verification data). Nomyx is a Processor, not a Controller, of personal data that we process on behalf of our Subscribers when they use Nomyx products and Services. For clarity, this means that this Notice does not apply to where Nomyx processes personal data as a processor in its products and Services.



If you have questions related to how a Nomyx Subscriber utilizes your personal data, please contact them directly. We are not responsible for the privacy or data security practices of our Subscribers. This Notice also does not apply to personal data about current and former Nomyx employees, job candidates, or contractors and agents acting in similar roles.

1. Introduction

This Notice applies to Nomyx Technology Labs Inc. and its relevant Affiliates listed in Section 14 ("**Nomyx**," "**us**," "**we**," or "**our**"). Capitalized terms that we use but are not defined in the Notice (such as Site, Services, Subscriber, Agent, Agent Contact Information, etc.) have the meaning provided in our Main Services Agreement. If you are located in the European Economic Area ("**EEA**"), Switzerland, or the United Kingdom ("**U.K.**"), please refer to Section 11 of this Notice for more information about which specific entity or entities act as a controller of your personal data.

When Does This Notice Apply? This Notice only applies to personal data that Nomyx handles as a Controller (meaning where Nomyx controls how and why your personal data is processed). This includes when you:

- Visit or interact with the Nomyx.io Site, the Nomyx mobile applications, the Nomyx Marketplace, the Nomyx Developer Portal, our branded social media pages, and other Sites which we operate (collectively, our "**Digital Properties**");
- Register for or participate in our webinars, events, programs, marketing, and promotional activities;
- Interact with us in person, such as when you visit our offices;
- Inquire about or engage in commercial transactions with us;
- Register for or participate in tokenized securities offerings through our platform;
- Complete investor verification processes for securities transactions;
- Interact with our securities tokenization services;
- Submit documentation for accredited investor verification; and
- Use our blockchain interfaces or smart contract deployment tools.

Changes: We may update this Notice from time to time. Please check back periodically for updates. If you do not agree with any changes we make, you should stop interacting with us. When required under applicable law, we will notify you of any changes to this Notice by posting an update on our Site or in another appropriate manner.

2. Personal Data We Collect and Disclose

2.1 Important Notice: Blockchain Data Permanence

WARNING: Blockchain Data Cannot Be Deleted

When you use our tokenization services, certain data becomes permanently recorded on blockchain networks:

- Wallet addresses



- Transaction history
- Token ownership records
- Smart contract interactions

This data is publicly visible and cannot be modified or deleted. We recommend:

- Using privacy-preserving techniques where possible
- Carefully considering what data to submit for on-chain recording
- Understanding that blockchain data persists even after account deletion

- **DFNS**: Institutional wallet infrastructure
- **1Transfer**: Transfer agent and cap table services

These providers may independently determine how they process data for regulatory compliance. Review their privacy policies for details.

5. Cookies and Tracking Technologies
