OIC Transportation Service: Policy & Guidelines

Purpose & Scope

The **OIC Transportation Service** helps individuals attend **church-sponsored worship services and activities**. It is a volunteer ministry of One In Christ Church, not a commercial transportation service.

Priority is given to college students, teenagers (with parent or guardian consent), seniors, and those with genuine transportation needs.

Scheduling & Return

Riders must be **ready at the designated pickup time and location**. Vehicles may depart if a rider is late. Please give advance notice for any change or cancellation.

Return rides are not guaranteed—OIC will assist when possible, but riders should plan for their own way home.

Safety & Conduct

For everyone's safety:

- Seat belts must be worn while the vehicle is in motion.
- Remain seated, store belongings securely, and avoid distracting the driver.
- Alcohol, tobacco, or illegal substances are **not permitted**.
- Riders are expected to show **respect and cooperation** toward drivers and passengers.
- Disruptive or unsafe behavior may result in suspension of ride privileges.
- Minors must have a signed waiver on file from a parent or guardian.

Drivers & Vehicles

- All drivers are approved **volunteers** of the OIC church.
- Vehicles must be insured, registered, and properly maintained.
- The service complies with all applicable state and local traffic laws.

Rights & Limitations

OIC Transportation Service may **deny**, **limit**, **or cancel** rides based on safety, capacity, weather, or other valid reasons. Policies may be updated as needed.

This ministry is provided as a **voluntary service of One In Christ Church**, not as a public or for-hire transportation entity.
