- I recently met with the VP of Business Development from Housing Visions to discuss our goals for housing in the Town of Champlain. It was a very positive meeting. I presented the various property locations that have been listed in our Comprehensive plan as desired locations for housing. I provided the two housing studies that were completed for recently and he will be compiling data now to determine the feasibility for a building approximately 60 units here in Champlain. We have recently applied for funding to conduct a site-specific market study as well.

- I recently attended the North Country Chamber of Commerce's Press release for We will Stand Together with our Canadian neighbors. This initiative is to remind all of us here in the US especially in this North Country region that our Canadian friends and family across the border have always stood by us over the years.

- I have reserved a Table at the North Country Chamber of Commerce's Annual Dinner again this year. This is primarily for members of each of the Village and Town Boards to attend. I hope to see many of our board members at the table. It is always a great

evening and it is a pleasure to be there to witness the various awards presented to our area businesses.

Report on projects:

- “Eat Smart Waste Less” Food Waste Program.
 - To date since we started this in May of this year, we along with the Champlain Village have collected just shy of one ton of food waste. Please consider joining in as it is great program that will help reduce the amount of methane gasses in our landfills and create compost for our farmers.
- Complete information on this program can be found on our website.
- The Nex Trex Plastics Program
 - Thank you to all who have been donating plastics to be recycled for this project, and thank you to Price Chopper/Market 32 for sponsoring this!
 - To date, since we started this in 2023, we have collected just shy of 7,000 pounds of plastic!
 - Thank you to all of our partners, Northern Tier Senior Housing, Champlain Rouses Point Kiwanis, A.N. Derringer, CTG and Champlain EMS.
- Comprehensive Plan Revision.
 - The Draft Comprehensive Plan is posted on our website and available in the Town Clerks Office.
 - The public hearing is tonight, December 9th to present the Draft Document for public comment.
 - Completion of the SEQR and adoption of the Final Plan is scheduled for the January 13th meeting.
- Miromar properties:
 - The 19 acres with the mall and the adjoining 7.5 acres:
 - It was confirmed by the property owners’ attorneys that they are hopeful to be going under contract with a buyer this November and that did not happen yet. I have requested that our attorney investigate the status.

- The 22 acres submitted for housing:
 - I am not sure if this particular buyer/developer has interest in this property as well for some type of housing. I have requested contact information to possibly have a conversation on their plans and have not received any information.
- Bob Venne Community Park:
 - Pickleball Courts
 - The surface coating and installation of the nets will be taking place as weather permits in the spring.
- Great Chazy River Project:
 - LCLGRP has submitted the Grant application to NYSDOS for a Local Waterfront Revitalization Program (LWRP). It has been through the regional review and is now with the state. The announcement for this grant will be either in December 2025 or January 2026. I will update when more information is available.
- Clinton County Heath Dept. Complete Streets:
 - Items still on the queue for completion next summer.
 - Crosswalk at Church Street and South Street.
 - Removal of the Shared Road markings on Prospect St.
 - New Shared Road markings for the trail along Prospect.
 - No parking signs for Perry Mills Park.
- Elm Street Culvert Project:
 - Stantec is currently developing design alternatives and preliminary plans. We have received the preliminary draft of the Initial Proposal and Final Design Report last month for our review.
 - There will be an Informational Public Meeting held here at the Town Offices on December 17, at 6:00 Pm. If you wish to learn about the design and construction of this project please attend this meeting. It is not a public hearing therefore; you will be able to ask questions and receive answers directly from the Engineers.

- We are still hopeful to be under construction in summer of 2026 although due to the requirement for NYS Easements it is likely that it will not go out to bid until September 2026.
- Bob Venne Community Park Electricity Project:
 - The electrical pedestal has been installed by the Highway Dept. Thank you to Allen and the men for doing this for us.
 - CTG has set the pole for the camera and has dug the trenches for the conduit to be installed by the electrician. This work has been donated by CTG and we are indebted to this local company for their generous community service. Thank you CTG!
 - The electrical work is completed and it has passed inspection. Waiting for NYSEG to schedule next.
- Sewer District Seven Project:
 - The Intermunicipal agreement (IMA) has been approved, signed and delivered to the funding agency.
 - Barton & LoGiudice are currently drafting the development, design and preliminary plans for construction.
 - Please Note: The Engineering firm will continue to have staff visiting properties that they have not been able to visit within the district to collect installation data for the design documents. They will either stop in or if they have contact information, they may set an appointment to ask questions, take photos and take measurements of your current utilities.

Public Announcements:

- The Town is continually seeking to appoint more alternates to the Zoning Board of Appeals and the Planning Board. - Thank you to all Veterans, and active Military Men and Women for your Service. Also, thank you to all first responders both paid and volunteer, of our EMS and Fire Departments; and our police officers for your dedication to your community.

Council Member Moore stated I have been driving around the Town and it is looking good compared to other Towns. I would like to Thank everyone and to continue to keep going forward in the Town and I am very impressed with this Board

Council Member Huner stated as the cold weather and icy conditions have set upon our community, the Town asks each of its residents to kindly keep an eye on your elderly neighbors. The Champlain Fire District is cleared everything and waiting for CO. We are working on the water agreement between the Town/Village and Fire District. With the Holiday Season please practice holiday safety. Increase heating introduces added risks. Do not overload outlets with multiple heaters and plug space heaters directly into the wall. Inspect and clean your heating systems and chimney flue, inspect all cords for fraying, install spark arrester, clear the area, test smoke/CO2 alarms monthly and keep fireplaces clear with screens, keep generators outside of the home and practice an escape plan. Rouses Point Fire Department will hold their Children's Christmas Party on December 20th from noon till 3:00 pm. There will be fire truck rides, cookies, and hot chocolate at the Fire Station at 48 Lake Street. Upcoming Rouses Point Village Board Meetings, Monday, December 15th and Monday, January 5th at 7:00 pm at Halstead Hall. Again, regular monthly meetings are the first and third Mondays of each month and are open the public. The Village Office and Rouses Point Dodge Memorial Library will be closed in observance of Christmas and December 24th and 25th and Thursday January 1st in observance of New Years Day. I contacted the Village of Rouses Point for Public Skating and Stick n Puck hours. I was informed new hours should be available this coming week, so please check the Village of Rouses Point website. Village of Rouses Point Winter Parking Ban will be in effect from December 1, 2025 through March 31, 2026. During this period, on-street parking is prohibited between 12:00 AM to 7:00 AM to allow for snow removal. Rouses Point Dodge Memorial Library new hours of operation: M,T,Th and F 10:00 am – 5:00 pm, Saturday 10:00 to 1:00 and closed on Sunday and Wednesdays. Friends Board of Directors Meeting is the third Wednesday, of the month, upcoming meeting is on December 17th at 5:30 pm in the Ross Nonfiction Room which is open to the public. Library Board of Trustees meet the second Wednesday of the

Month at 5:15 pm in the Ross Nonfiction Room and their next meeting is tomorrow December 10th and is open to the public. Zoning Board of Appeals will meet on January 12th at Halstead Hall at the Rouses Point Civic Center; normal meetings are held the second Monday of each month at 6:00 PM unless otherwise noted. Meetings are open to the public. St. Patrick's Church in Rouses Point offers food assistance each Wednesday from 9:30 to 10:30. Approval was given for the town to be lead agency for the Joint Smart Growth Comprehensive Plan established for the Village and Town of Champlain. The next Planning Board Meeting is scheduled for January 8th. Adult swimming sessions currently underway and with room for more participants. Resolution #58 of 2025

To enter into the Intermunicipal Water Agreement between the Town of Champlain, Village of Champlain and the Champlain Fire District.

WHEREAS, the Village of Champlain owns and operates a Consolidated Water service facility, serving its residents and Town residents through a delivery system and a water treatment plant; and the Town operates a portion of this delivery system within the Town limits titled as Water District #6, which serves the new fire station at 11006 Route 9 Champlain NY; and,

WHEREAS, the Town Board has approved entering into this IMA under Resolution #45 on October 14, 2025 at the regular business meeting however, the Village of Champlain disapproved the IMA primarily due to the 35-year term requiring a revision to Section 2, Term of Agreement, at their November 10th meeting; and,

WHEREAS, the revised IMA was presented to the Champlain Fire District during their Business Meeting held on November 25, 2025 with the Village of Champlain Mayor present, and in agreement of the revision which was then formally approved by the Board of Commissioners of the First District; and,

WHEREAS, the revision to Section 2 defined the term of the agreement as open ended with no expiry date with a condition that all three municipalities review and approve this agreement annually at each of the respective organizational meetings; and now,

WHEREAS, the Town and Village will supply water as per the Intermunicipal Agreement (IMA) between the Town and Village of Champlain and the Champlain Fire District at \$0.00 per K-Gal (no-charge) to the Champlain Fire District upon the terms set forth therein the agreement for an open term with no expiry date commencing on January 1, 2026 unless earlier terminated pursuant to the provisions thereof or as otherwise provided by law or regulation; and,

WHEREAS, it is recorded that the Town will charge the Champlain Fire District the standard service fee for water users as per annual budget appropriations; and,

THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Champlain does hereby approve entering into this IMA with the aforesaid revision between the Village of Champlain, the Champlain Fire District and the Town of Champlain, as governing board of Water District #6, a New York Municipal Corporation with offices at 10729 Route 9 Champlain, NY.

AND BE IT FURTHER RESOLVED, that a roll call vote is carried to approve said resolution.
