NOTICE IS HEREBY GIVEN that, pursuant to Section 179 of the Town Law, a Special Election of the qualified voters of Champlain Fire District in the Town of Champlain, Clinton County, New York, will be held at the Fire Station, at 11006 Route 9, in Champlain, New York, in said Fire District, on the 14th day of July, 2026, between the hours of 6:00 o'clock P.M. and 9:00 o'clock P.M., Prevailing Time, for the purpose of voting by paper ballot upon the adoption or rejection of the following resolution:

A RESOLUTION AUTHORIZING THE SALE OF SURPLUS REAL ESTATE
FOR THE CHAMPLAIN FIRE DISTRICT IN THE TOWN OF CHAMPLAIN
(162 ELM STREET, CHAMPLAIN), CLINTON COUNTY, NEW YORK.

WHEREAS, it is now desired to authorize said sale of real estate;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Champlain Fire District in the Town of Champlain, Clinton County, New York, as follows:

Section 1. Upon this resolution taking effect, the same shall be published in summary form in the official newspaper of said Fire District for such purpose, together with a notice of the Fire District Secretary in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 2. This resolution is adopted subject to approval at a Special Election of said Fire District to be held on July 14, 2026.

A RESOLUTION AUTHORIZING THE SALE OF SURPLUS REAL ESTATE (162 ELM STREET, CHAMPLAIN) FOR THE CHAMPLAIN FIRE DISTRICT IN THE TOWN OF CHAMPLAIN, CLINTON COUNTY, NEW YORK, duly adopted by the Board of Fire Commissioners of said Fire District on the 26th day of May 2026, be approved?

Pursuant to subdivision 4 of Section 179 of the Law, every elector of the Town of Champlain who shall be a registered voter of such Town and who shall have resided in the Fire District for the period of thirty days next preceding the election which is the subject of this notice shall be qualified to vote upon such proposition.
