1. Project Background and Objective

2. Scope of Services

The successful bidder will be responsible for:


- International Transportation: Multimodal transport (sea / air / road) from China, the Philippines, Thailand, Japan, India, and from everywhere else, to Mbale or Kampala.
- Customs Clearance: Full management of import documentation, duties, and compliance with Ugandan customs regulations.
- Warehousing and Distribution: Temporary storage, inventory management, and final-mile delivery to distribution centers.
- Tracking and Reporting: 24/7 real-time shipment tracking through GPS and digital platforms.
- Risk Management: Proactive identification and mitigation of transport-related risks, including insurance coverage.
- Emergency Management: Contingency plans for delays, natural disasters, or supply chain disruptions.

3. Mandatory Eligibility Criteria

Bidders must provide the following:

- Experience: At least five (5) years of proven experience in international logistics.
- Financial Capacity: Audited financial statements for the last three years (2022–2024).
- Compliance: Valid operating licenses and ISO certifications (ISO 9001, ISO 14001, or equivalent).
- Safety and Security: Evidence of safety management programs, accident statistics, and cargo security measures.
- References: Contact details of at least three clients for whom similar services were provided.

Proposals must include:

- A detailed methodology and logistics plan for service delivery.
- Organizational structure and profiles of key personnel.
- IT capabilities for shipment tracking and reporting.
- Sustainability initiatives, including CO₂ tracking, green fleet options, and waste reduction practices.
- A detailed pricing structure covering freight, customs clearance, warehousing, insurance, fuel surcharges, and any additional fees.
- Sample Key Performance Indicators (KPIs), such as on-time delivery, damage rates, and response times.

5. Evaluation Criteria

Key evaluation criteria include:

- Network coverage and transit times
- Technology integration and reporting capabilities
- Financial competitiveness and transparency
- Environmental sustainability practices
- Risk management and contingency planning
- Experience with similar international supply chains

9. Eligibility and Qualification Criteria

The selection will follow the Quality and Cost-Based Selection (QCBS) method with the following weightings:

- Administrative Compliance: 20%
- Technical Compliance: 60%
- Financial Compliance: 20%

The contract will be awarded to the bidder achieving the highest combined score across administrative, technical, and financial evaluations.
