

# Missouri 2015 Fund



## Objective

The objective for each retirement fund is to achieve the highest total return over time combined with an appropriate level of risk that is consistent with its asset mix, as described below

## Investment Strategy

- A diversified portfolio of equities and bonds built for investors who retired around 2015, typically those born between 1948 and 1952
- Investment mix becomes progressively more conservative over time as the Fund approaches and passes through its target retirement date
- Targets up to 7.5% of the Fund's total assets in REITs, which may provide attractive income combined with a historically low correlation to other asset classes

## Primary Investments

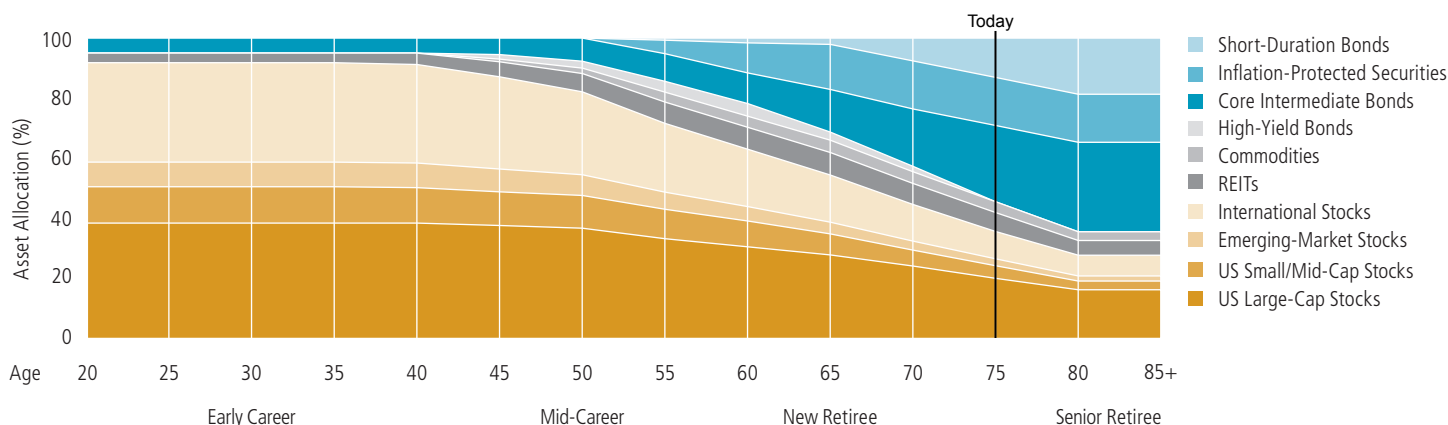
- Equity holdings are diversified across investment styles, company sizes and geographic regions, as well as real estate investment trusts (REITs)
- The fixed income portion of the portfolio invests primarily in investment-grade bonds, but may also include high yield bonds

## Manager Summary

The Missouri Target Date Funds are managed by AllianceBernstein L.P. AllianceBernstein designs and implements the asset allocation and actively manages the glidepath. State Street Investment Management (SSIM) passively manages the US Large Cap Stocks, US Small and Mid Cap Stocks, International Stocks, Emerging Markets Stocks, REITs, Commodities, Core Intermediate Bonds, and Inflation-Protected Securities investment components. Vanguard actively manages the High Yield Bond investment component. BlackRock Institutional Trust Company (BTC) passively manages the Short Duration Bond investment component.

## Investments Become More Conservative Over Time



**A WORD ABOUT RISK—Market Risk:** The market values of the portfolio's holdings rise and fall from day to day, so investments may lose value. **Interest Rate Risk:** Fixed-income securities may lose value if interest rates rise or fall—long-term securities tend to rise and fall more than short-term securities. ## Other Important Information

The benchmark for a Missouri Target Date Fund is a customized benchmark that has the same target asset allocation as the Fund's target asset allocation and uses index returns to represent performance of the asset classes. The benchmark returns were calculated by weighting the monthly index returns of each asset class by the Fund's monthly target allocation for each asset class. Target allocations adjust quarterly in accordance with the Missouri Target Date Fund's standard glide path. The S&P 500 Index is used to represent US Large-Cap Stocks, Russell Small Cap Completeness Index® to represent US Small/Mid-Cap Stocks, MSCI Emerging Markets Index to represent Emerging Market Stocks, MSCI EAFE Index from inception to 08/14/2020 and MSCI World ex-USA Index from 08/15/2020 to present to represent International Stocks, Dow Jones US Select Real Estate Securities Index<sup>SM</sup> to represent REITs, Bloomberg Commodity Index from inception to 04/28/2017, Bloomberg Roll Select Commodity Index from 04/29/2017 to 03/31/2025 and Bloomberg Enhanced Roll Yield Total Return Index from 04/01/2025 to present to represent Commodities, Bloomberg Ba to B US High Yield Index from inception to 11/30/2014 and a composite of 95% Bloomberg US High-Yield Ba/B 2% Issuer Capped Index and 5% Bloomberg US 1-5 Year Treasury Bond Index from 12/01/2014 to present to represent High Yield Bonds, Bloomberg US Aggregate Bond Index to represent Core Intermediate Bonds, Bloomberg US TIPS Index from inception to 07/31/2014 and Bloomberg 1-10 Year US Government Inflation-Linked Bond Index from 08/01/2014 to present to represent Inflation Protected Securities, Bloomberg 1-3 Year Government Index to represent Short Duration Bonds.
