

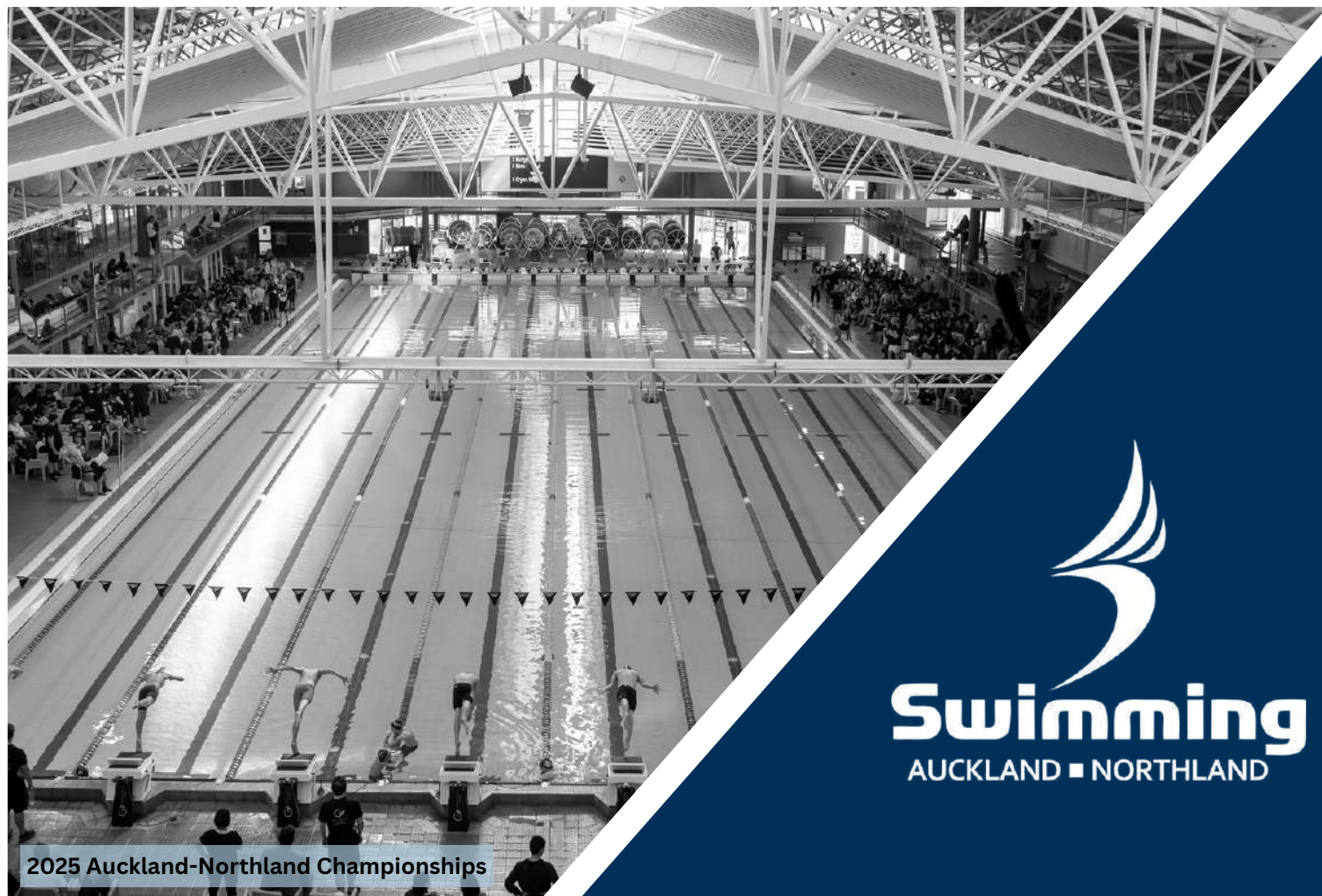

Swimming Auckland-Northland Board Chair Report 2024 – 2025

I would like to extend my heartfelt appreciation to our Board Members for their unwavering support and dedication over the past year. Your collective wisdom, resilience, and commitment have been invaluable, especially as we navigated several challenges. Each member has contributed unique strengths, and together, you have upheld the high standards expected of the Board.

This year, we maintained a prudent approach to our finances, carefully managing liabilities to ensure long-term stability. A key milestone was the full repayment of the Small Business Loan from the IRD, secured during the COVID-19 period.

Claudia accepted the position of General Manager of Swimming Auckland in July 2024. Her enthusiastic and dedicated leadership has already driven significant improvements across our organisation. I also want to acknowledge Jazmyn for her valuable administrative support, which has enhanced our internal operations and strengthened communication between Administration and Clubs. Thanks to the dedication of our Administration Team, we've seen marked improvements in communication channels and overall efficiency.

This year, we welcomed the University Swimming Club into our community. While the formal merger between Northland and Auckland was finalised in February 2025, Northland Swimming Clubs effectively joined Swimming Auckland in June 2024. The integration was symbolically marked by the adoption of a new logo in 2025. Today, Swimming Auckland-Northland proudly represents one-third of the national membership under Swimming New Zealand (SNZ).

On the national stage, I was appointed to the SNZ Governance Review Group. While the group initially made encouraging progress, its work was paused to prioritise the alignment of the SNZ Constitution with the new Incorporated Societies Act. That process culminated in the successful adoption of a revised Constitution at the SNZ Special General Meeting in June 2025. We anticipate that the Governance Review Group will reconvene shortly to resume its important work.

Operational challenges at West Wave remained a concern. The nine-week closure from April to June significantly disrupted Swimming Auckland-Northland competitions, Wai Zone events, and various Club competitions. We commend Waitakere Swimming Club for their resilience, particularly as West Wave is their sole training venue. We are encouraged by the recent upgrades and hopeful they will improve the facility's long-term reliability.

Our Technical Group has expanded with a solid foundation of skilled and knowledgeable individuals. Meanwhile, our Technology Group has faced persistent challenges. I would like to particularly acknowledge Tony Cooper for his tireless efforts in maintaining our technology infrastructure. His work has ensured continuity in the face of ongoing issues with the scoreboard and facility wiring. The successful Quantum calibration this year has also safeguarded the viability of our competition systems.

We are proud to confirm that our own Constitution has been thoroughly revised and is now fully compliant with the new Incorporated Societies Act. The updated Constitution was formally adopted at our Special General Meeting on July 23rd. The constitution has been lodged with Incorporated Societies along with the declaration that Auckland Swimming Association will be continuing as an Incorporated Society. In addition, our Administration Team has been actively working with clubs to support them in updating their own constitutions to ensure full compliance.

One pressing concern we continue to raise relates to decision-making processes at Swimming New Zealand, specifically around recent changes impacting Development Meets. These meets are a critical entry point for young swimmers, providing a structured and supportive environment to gain competitive experience. Their alteration or removal poses a serious risk to the grassroots development pathway, which is foundational to our sport's future.

Given that Swimming Auckland-Northland represents a third of SNZ's total membership, we strongly believe that our region's perspective must be adequately considered. The preservation and, where necessary, enhancement of Development Meets is essential to nurturing emerging talent. We urge Swimming New Zealand to engage meaningfully with regional bodies and those involved in grassroots swimming before implementing decisions that affect young swimmers' opportunities.

Collaboration, mutual respect, and open dialogue between national and regional bodies are essential if we are to grow participation and achieve excellence in swimming across New Zealand.

In conclusion, I offer my sincere gratitude to everyone who has contributed to the success of Swimming Auckland-Northland, our Board Members, staff, volunteers, club leaders, and swimmers. Your ongoing commitment helps shape a vibrant, inclusive, and forward-looking swimming community.

It has been my honour to serve you as Chair of the Swimming Auckland-Northland Board.

General Manager's Report 2024 - 2025

The year began with an interesting issue for the swimming community when we were advised that the rewards and records award was being scrapped by SNZ. This did not sit right with us, as swimmers were still being charged the fee. We submitted an item of business at the 2024 SNZ AGM, and as a result, the fee was removed. The fees already paid to SNZ since the 1 July rollover were subsequently proposed to be re-imbursed, with the option for members to donate their refund to the NZ Swimmers Trust. This resulted in a substantial donation of \$20,000.00 which was gratefully acknowledged and goes a long way to supporting our high-performance swimmers. Thanks must go to the entire swimming membership for their generosity.

We also found ourselves challenging the proposed SNZ constitution. A great deal of work had already been initiated by the governance review group. A constitutional working group was ultimately established and I was appointed to this group, to work through the issues, with an amended constitution approved by the membership in place since June. The final reviews are still in progress and likely to be completed before the SNZ AGM.

In May this year we were advised of the new fee structure for SNZ. Swimming Auckland-Northland felt strongly that the proposed split fee structure with a lower fee for 12/U swimmers was unfair on senior swimmers who already face much higher costs by way of training fees, meet entry fees, gym training and further cost associated with sport such as travel and accommodation. We successfully lobbied SNZ for a flat fee structure across the board for all registered swimmers which they have agreed to for this year.

Swimming Auckland-Northland's strong focus on the grassroots is a real strength for the growth of the sport in the region, and we are one of the only regions to deliver such a comprehensive and regular event by way of our Development/Level 3 meets to help with the development of young swimmers in a safe and relaxed environment. It is vital that this pathway is preserved and continued.

We hosted a number of highly successful regional meets over the past year. These were well attended by our local swimmers as well as visitors outside of our region. The increase in entries is very encouraging as it shows our sport is back in growth mode, as also evidenced by the growth in registered competitive swimmers year on year. It has been an absolute pleasure to welcome the Northland swimmers into the fold and see them racing alongside our Auckland based competitors. The many records set over the past year both regionally and nationally are a true testament to the commitment and determination shown by our swimmers, and to the quality of our meets and calibre of our coaches.

In addition to the regional meets we saw a number of clubs hosting successful interclub competitions. It was great to be able to assist and provide guidance to Phoenix who hosted their first ever interclub meet.

The Caro Cup was retained by Auckland in what was a very lively atmosphere with some strong competition in the pool. The very enthusiastic coaches and team managers helped to create a fun and vibrant environment for our swimmers, you are a credit to our sport.

I also had the pleasure of officiating at the Special Olympics together with some of our officials in June, and in July we hosted the North Island Masters Short Course Champs, thereby extending relationships with other organisations in the wider swimming community.

While there are ongoing challenges, especially access to pool space, I am pleased to report that our relationship with Westwave is strong and continues to improve. We have generously been given access to long course training on Saturdays when the pool is available which is well utilised by a number of clubs. The extended closure earlier this year impacted on our schedule with several meets relocated to other pools. Prior to the closure we were able to run several long course meets under a modified set up while the closure and repair was in the planning stages without any hitches, thanks to support from Westwave in assisting with modifications to the pool which allowed us to run our electronic timing equipment.

I am very grateful to our many volunteers, who give so generously of their own time. This includes both officials on pool deck during meets, and the administrators working behind the scenes. Our meets would not happen without you. It takes approximately 50 people to run an approved meet session, and that does not include all the administrative preparation that goes on in the weeks leading up to the meet before the racing can start.

The Working Groups, that is the Technical, Technology and Competitive Swimmers Group continue to provide us with their invaluable input and experience ensuring that Swimming Auckland-Northland functions at the highest level of professionalism and ensuring that we deliver some of the best managed swimming events in New Zealand, and to a high standard.

Lastly I would like to express my appreciation to Shirley Mackay and the board for their guidance over the past year. Our board members come from a range of professional backgrounds, and all willingly contribute their own expertise in a range of ways. Swimming Auckland-Northland is very lucky to have your services and we are grateful for your contribution.

Basis for Qualified Opinion

Cash donations, grants and sponsorships are a source of income for Auckland Swimming Association Inc. The Association has determined that it is impracticable to establish control over the collection of cash grants, donations and sponsorships prior to entry into its financial records. Accordingly, as the evidence available to us regarding income from this source was limited, our audit procedures with respect to cash donation, grants and sponsorships had to be restricted to the amounts recorded in the financial records. We therefore are unable to express an opinion whether cash donations, grants and sponsorships Auckland Swimming Association Inc has recorded are complete.

We conducted our audit of the statement of financial performance, statement of financial position, statement of cash flows, statement of accounting policies and notes to the performance report in accordance with International Standards on Auditing (New Zealand) (ISAs (NZ)), and the audit of the entity information and statement of service performance in accordance with the International Standard on Assurance Engagements (New Zealand) ISAE (NZ) 3000 (Revised). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Performance Report section of our report. We are independent of Auckland Swimming Association Inc in accordance with Professional and Ethical Standard 1 (Revised) Code of Ethics for Assurance Practitioners issued by the New Zealand Auditing and Assurance Standards Board, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other than in our capacity as auditor we have no relationship with, or interests in, the Auckland Swimming Association Inc.

Notes to the Financial Statements

1. Statement of Accounting Policies

These are the financial statements of Auckland Swimming Association Inc. which is an incorporated society established under the Incorporated Societies Act 1908.

Basis of Preparation

Auckland Swimming Association Inc. has elected to apply Public Benefit Entity Simple Format Reporting – Accrual (Not-For-Profit) (PBE SFR-A (NFP) Entities as established by the External Reporting Board (XRB). This is on the basis that it does not have public accountability and has total annual expenses equal to or less than \$5,000,000 for the last two annual reporting periods. All transactions in the Statement of Profit & Loss are reported using the accrual basis of accounting. The Statement of Profit & Loss is prepared under the assumption that the society will continue to operate as a going concern in the foreseeable future.

Historical Cost

The financial statements have been prepared on a historical cost basis.

Revenue

Entries and Fees that are attributable to the current financial year are recorded as revenue.

Fixed Assets

Fixed assets are included at cost less aggregate depreciation provided at the maximum rates allowed by the Inland Revenue Department. Fixed assets that are leased under a finance lease are capitalised and depreciated. The depreciation rates used are shown in the Depreciation Schedule.

Income Tax

The Association is deemed to be an amateur sports promoter by Inland Revenue and has been granted exemption from paying Income Tax under the Income Tax Act 2007.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Goods and Services Tax

The Statement of Profit and Loss has been prepared on a GST exclusive basis. All items in the Balance Sheet are stated exclusive of GST with the exception of receivables and payables which include GST.

Accounts Receivable

Accounts Receivable are stated at estimated realisable value, after providing against debts for which collection is considered doubtful. Bad debts are written off during the period in which they are identified.

Grants

Grants received are included in operating income. If particular conditions are attached to a grant that would require it to be repaid if these conditions are not met, then the grant is recorded as a liability until the conditions are satisfied.

Changes in Accounting Policies

There have been no specific changes in accounting policies and they have been applied on a consistent basis with those of the previous period.
