The sustainability label for SMEs

Label

Upon successful completion of the seminar, **participants** receives the status:

'Certified Sustainability Expert'.

For communication purposes, such as on the website, annual report or ESG report, the respective **SME** can also use the label

'Certified Sustainability Board'.

The sustainability label shows stakeholders that the management and board of directors actively and thoroughly address sustainability issues.

To be authorised to use the label, at least one member of the Executive Board or Board of Directors must have completed the 'Certified Sustainability Expert' seminar.

Knowledge and Label Update

Seminar graduates have the opportunity to register for the continuing **e-training (expert videos)** offer.

In order to maintain the 'Certified Sustainability Board' label, it is required that the seminar graduate attends the e-training annually (*expert video modules are recorded & provided*).

This ensures that you stay up to date with the latest developments in ESG and reporting and can continuously improve your company's sustainability strategy.
