WORKFORCE PELL NEGOTIATED RULEMAKING

This week, we've been following the U.S. Department of Education's Negotiated Rulemaking sessions for the new Workforce Pell program. Authorized in last summer's "One Big Beautiful Bill Act," the program extends Pell eligibility to short-term (fewer than 600 instructional hours), workforce-aligned programs.

WCET and SAN are closely monitoring these discussions, particularly potential implications for interstate distance education and institutions with multi-state online enrollment.

This interactive session covered the history and purpose and address the nuances of SARA compliance, including professional licensure disclosures, out-of-state placements, and recent policy updates. Members got clarity on their institution's responsibilities and learned best practices directly from the source—our presenters, Dr. Marianne Boeke, President, NC-SARA and Jeannie Yockey-Fine, Senior Vice President and General Counsel, NC-SARA. This was a unique opportunity to strengthen our institutions' compliance efforts and to get answers to our most pressing questions.

FL-IDN LATEST WEBINAR: UNIVERSAL DESIGN FOR LEARNING: BUILDING ACCESSIBILITY FROM THE GROUND UP

Earlier this month, FL-IDN hosted a webinar, "Universal Design for Learning: Building Accessibility from the Ground Up." This session explored how to implement Universal Design for Learning (UDL) principles from the beginning of course design rather than retrofitting accessibility features after courses are complete. Participants examined the time and resource costs of the retrofitting approach and learn practical workflows that scale from individual documents to complete course components. Our guest speaker, Samantha Groh (University of Cincinnati), included demonstrations of tools and case study examples that illustrate accessibility implementation in real-world contexts, along with strategies for presenting accessibility as an enhancement that benefits all students. TRANSIENT STUDENT ADMISSIONS APPLICATIONS SEE STEADY INCREASE

Transient Student Admissions Applications created for Fall 2025 (15,380) increased by 4.6 percent when compared to the Fall term last year (14,698). For the Spring 2026 term so far, applications (8,103) have increased 5 percent compared to the same period last year (7,714). At this point in the academic year there have been 23,830 applications created compared to the same time in 2024 (22,810), which is a 4.5 percent increase.

INSTITUTION SPOTLIGHT: UNIVERSITY OF FLORIDA ATHLETIC DEPARTMENT AMONG THOSE THAT OPTIMIZE PERFORMANCE WITH AI

"At the University of Florida, soccer players meet with trainers to measure their hamstring flexibility, groin strength and overhead squat stability to prescreen them for injury risk. Football players arrive at practice wearing sensors that measure their speed, acceleration and force. And gymnasts jump from plates that measure their explosive power.

Then, this information—along with countless other <u>data points</u>—is fed into an artificial intelligence data bank.

UF is one of a growing number of schools bringing artificial intelligence into their athletics departments to give coaches and athletes an edge. Just as universities compete to build the biggest stadiums and best training facilities, they are now racing to plant their flags in the next frontier of sports analytics. While it is still early, Al adopters hope the technology will help prevent injuries, optimize performance and uncover winning strategies."

INSTITUTION SPOTLIGHT: UWF B.S. IN CYBERSECURITY AI SPECIALIZATION APPROVED AS A NATIONAL CENTER OF ACADEMIC EXCELLENCE IN CYBER ARTIFICIAL INTELLIGENCE PROGRAM OF STUDY

'The University of West Florida's new AI specialization in the B.S. in Cybersecurity program has been validated as a National Center of Academic Excellence in Cyber Artificial Intelligence Program of Study from the National Security Agency through 2030. UWF was the second university across the country to receive this approval and one of only 6 out of the more than 495 NCAE-designated institutions across the nation to receive the new NSA NCAE Cyber AI program approval this year.

'This is another accolade to be added to the cybersecurity program at UWF," said Dr. Mohamed Khabou, dean of the Hal Marcus College of Science and Engineering. "Being among the first institutions in the U.S. to receive this approval is a testimony to the quality of the program and the great synergy between the Department of Cybersecurity and Information Technology and the Center for Cybersecurity."

The NSA NCAE Cyber AI Program of Study validation is a new recognition honoring universities that demonstrate excellence in the integration of artificial intelligence and cybersecurity into their programs. The NSA NCAE Program created the new Cyber AI Program of Study validation to address the rapidly growing national need for qualified cybersecurity and AI professionals. UWF offers high-quality undergraduate and graduate cybersecurity degrees and certificates and is part of the inaugural cohort of institutions nationwide to receive the new Cyber AI Program of Study Approval."

IN CASE YOU MISSED IT: SAN RELEASED A NEW "HOW TO" HANDBOOK TO BUILD AN INSTITUTION'S STATE-TO-STATE AUTHORIZATION PLAN

The State Authorization Network (SAN) is excited to share SAN's newest comprehensive resource, the State-to-State Institutional Approval for Distance Education Handbook, developed in partnership with Shari Miller, Institutional Compliance MATTERS.

This handbook is the third major SAN report designed to demystify complex compliance requirements when institutions offer interstate opportunities, whether through online courses or experiential learning.

All three major reports align with SAN's concise one-pagers and charts available in the <u>Getting Started with Compliance Management Gateway</u> on the SAN website, so institution teams can develop practical action.
