For the purposes of this Limited Warranty, Pebble Tec Material ("Material") is defined as pebble, glass beads, and pigment. This Limited Warranty is expressly limited to repair or replacement of the failed Material, the remedy to be determined at the discretion of Pebble Technology, Inc., and does not include labor and other costs for repair or removal. The Limited Warranty does not extend to failure of the Material caused by improper chemical maintenance, negligence, accidental misuse, or structural failure.

The Limited Warranty is non-transferable and only applies to Pebble Tec Material when installed by a Licensed Pebble Tec® Installer. Pebble Technology, Inc. must be permitted sufficient time, which may be as long as 60 days, and must be permitted sufficient opportunity to evaluate and confirm any defect in the Material, and to respond to any claims.
