To: Commercial Transportation of Solid Waste at John Smith Road Landfill

Subject: BUSINESSES TRANSPORTING SOLID WASTE TO JOHN SMITH ROAD LANDFILL

Date: May 18, 2022

Businesses that commercially transport solid waste within the County of San Benito and that dispose of waste at John Smith Road Landfill are required to provide an origination of waste document. Per San Benito County Code of Ordinances [Chapter 15.01 Solid Waste Regulations](#), the following code applies to commercial transportation of solid waste in San Benito County:

§ 15.01.061 ORIGATION OF SOLID WASTE DOCUMENT

It is unlawful for any person to transport solid waste, soil, or fill material within the county without an origination of waste document. An origination of waste document is a document which identifies the nature of the waste, where the waste was located before it was loaded for transportation, the estimated weight of the solid waste, a statement identifying the person in possession of the solid waste before the transporter of solid waste took possession of the solid waste and a statement identifying all transporters of solid waste. The origination of solid waste document shall be signed by the person in possession of solid waste before transportation of solid waste commenced and all transporters of the solid waste certifying under penalty of perjury the accuracy of the information contained in the origination of solid waste document. The county shall prepare a standard origination of solid waste document. The use of a copy of the standard form or any form substantially similar shall comply with this section.

A standard origination of solid waste document can be provided by contacting Integrated Waste Management or by request to the Landfill Operator. The use of this standard form or substantially similar form shall comply with this code section.

Per San Benito County Code of Ordinances [Chapter 15.01 Solid Waste Regulations](#), the following code applies to commercial transportation of solid waste disposed at John Smith Road Landfill:

§ 15.01.081 REQUIREMENTS TO DISPOSE OF SOLID WASTE IN JOHN SMITH LANDFILL

(A) No person engaged in the commercial transportation of solid waste shall be permitted to dispose of waste in John Smith Landfill unless the person shall possess an origin of waste document, a copy of which document shall be presented to the operators of John Smith Landfill.

(B) No person engaged in the commercial transportation of solid waste shall deposit solid waste in the John Smith Landfill without providing proof to John Smith Landfill operators or to the County of San Benito that the person has obtained a valid transportation of solid waste franchise from the County of San Benito, or proof from the County of San Benito Integrated Waste Management Department that the person is exempt.

(C) No person engaged in the noncommercial transportation of solid waste shall be permitted to dispose of the solid waste in John Smith Landfill without providing proof of residency in the form of a valid California driver's license or equivalent identification to the operator of the John Smith Landfill.

(D) For purposes of this section, a person engaged in the commercial transportation of solid waste shall be any person attempting to dispose of over one-half ton of solid waste.

The origin of solid waste requirements must be met for businesses to commercially transport solid waste and dispose of solid waste at John Smith Road Landfill. Failure to comply with these requirement will result in the commercial business being unable to transport solid waste or dispose of solid waste at John Smith Road Landfill.

Los negocios que comercialmente transportan desechos solidos dentro del Condado de San Benito y que eliminan desechos en el vertedero de John Smith Road deben proporcionar un document de origen de desechos. Por el codigo de ordenanzas del Condado de San Benito [Chapter 15.01 Solid Waste Regulations](#), el siguiente codigo se aplica al transporte commercial de residuos solidos en el condado de San Benito:

§ 15.01.061 ORIGINATION OF SOLID WASTE DOCUMENT

It is unlawful for any person to transport solid waste, soil, or fill material within the county without an origination of waste document. An origination of waste document is a document which identifies the nature of the waste, where the waste was located before it was loaded for transportation, the estimated weight of the solid waste, a statement identifying the person in possession of the solid waste before the transporter of solid waste took possession of the solid waste and a statement identifying all transporters of solid waste. The origination of solid waste document shall be signed by the person in possession of solid waste before transportation of solid waste commenced and all transporters of the solid waste certifying under penalty of perjury the accuracy of the information contained in the origination of solid waste document. The county shall prepare a standard origination of solid waste document. The use of a copy of the standard form or any form substantially similar shall comply with this section.
