HC directs Santosh Verma to submit specimen signatures in forgery probe

Indore: The Indore Bench of the Madhya Pradesh High Court has directed IAS officer Santosh Verma, who is also the state president of the Scheduled Caste and Scheduled Tribes Officers' and Employees' Association, to provide specimen signatures in connection with an alleged case involving forged and fabricated documents. The court ordered Verma to appear before MG Road police station in Indore and submit his signature samples to aid the ongoing investigation. The matter is being probed by MG Road police.
