Invoice Risk Analysis

Each submitted invoice is carefully assessed and assigned a risk rating. To support your investment decision, additional insights compiled by our risk managers are also available.

Individual Industry Assessment

We evaluate each industry's specific risk factors. Our assessment takes into account macroeconomic developments and sector-specific trends that may impact the payment behavior of debtors.

Risk Classification and Credit Limits

We classify invoices based on the financial standing of the debtor and other key risk indicators. A maximum credit limit is defined accordingly.

Payment History Analysis

We assess past payment behavior of debtors – such as delays or defaults – to better estimate payment reliability and risks.

Ongoing Monitoring

Our risk monitoring is a continuous process. Invoices are reviewed regularly to ensure risk developments are recognized early.

Debtor Verification

Each invoice is only accepted after a structured verification of the debtor and invoice details. This includes creditworthiness, sector performance, and internal scoring results from the Aequitex Invoice Scoring Algorithm®.

What types of factoring are available on the Aequitex Platform?

Non-Recourse Factoring


The invoice is purchased with risk assumed by the invoice buyer, including debtor management, which is handled by Aequitex on behalf of the buyer.

Recourse Factoring

The invoices remain at the risk of the seller (creditor) – discreetly, without notifying the debtor. Debtor management also remains with the seller.

Reverse Factoring

The invoice seller (debtor) finances their supplier invoice. The risk remains with them – for better terms and more stable supply chains.
