


### Take time for the "time of death"

State Auditor Shad White said Randy Hester and his aunt, Brenda Pittman, submitted fraudulent invoices to Quitman County under the disguise of a fictitious business name for services he did not provide.

#### Subject: Required MDILog entry of death records

This letter informs you that as a Coroner, under Mississippi Statute §41-61-63, you must enter the County's deaths into MDILog.

Upon receipt of notification of a death affecting the public interest, make inquiries regarding the cause and manner of death, reduce the findings to writing and promptly make a full report to the State Medical Examiner on forms prescribed for that purpose.

For your convenience, we have provided below, a 2024 case input comparison that shows how many deaths your county has entered Death Certificates for in EDRS and the number of cases entered in MDILog.



# A new coroner in town



- Know your state laws, rules and regulations for processing deaths.
- Know your Coroners' Numbers.
- Know your Coroners (How do you communicate with them?)
- Know when it's time to get some one else involved.
- Know what the community, media and families are saying about your coroner.
- Know the **new coroner in town** (phone call, lunch, offer support and watch the numbers).
