


# Model Law Update 2024

### What is the Model Law?

- It has no force of law by itself
- It's not an all or nothing document
- It's not meant to tell you what your law is supposed to be.
- Like a blueprint, you can make changes for your own Jurisdiction





## How can I use the Model Law?

- Full law replacement
- Sample language to address difficult issues
- Can help persuade law makers of a national standard
- Gives an idea of what other states may be doing

#### Model Law

This revision replaces the 2011 revision of the Model State Vital Statistics Act and Model State Regulations. The Model Law is a living document, and we encourage members to review it and submit their suggestions for changes for the Model Law Committee to consider. ### What's changed in the 2024 Model Law?

- Layout of Law vs Regulation
  - Regulations are numbered with the laws to which they pertain
- Added definitions for: Authentication, Authorization, Conveyance, Death, Gender, Healthcare Provider, Informant, Jurisdiction, Medical Certification, Medical Certifier, Midwife, Next of Kin, Presumptive Death, Public Health Purpose, Research, Role-based access, Sex, Standard Certificate

### What's changed in the 2024 Model Law?

- References to fluctuating terms such as "State" were put in parenthesis to help other types of jurisdictions easily identify places they needed to update.
  - Added a version 1 and 2 in places where states were doing things differently. (e.g. Section 6 Legislative authority vs State Registrar authority)

## What's changed in the 2024 Model Law?

- New Sections:
  - Regulation 10 Content of Vital Records and Vital Reports
  - Regulation 11.3 Surrogacy
  - Regulation 23 Report of Adoption or Foreign/International Adoption
- Significant updates
  - Gender neutral language regarding parentage
  - Language to address amending the sex/gender on birth certificates
  - Rules around data sharing agreements
  - Death Certificate filing timeline requirements
  - Updates to foundling and delayed requirements

# What if I have a suggestion for an update to the Model Law?

- Model Law will now be more of a living document
- Submit suggestions on NAPHSIS website and will be reviewed every 6 months
- Membership will vote on entire Model Law every Third Year

#### Advocacy 101

- The constitution grants us the right to petition the federal government for a redress of grievances
- The same is true at the state level: you can ask your legislators to make changes or improvements to state law, including how vital statistics are governed






#### Advocacy 101

| Lobbying                                                                          | Education                                                                                                           |

| Asking legislators to take specific action related to a policy or funding request | Sharing your personal story                                                                                         |
| Government officials and employees may be restricted                              | Communicating the importance of a policy or funding issue to people in a position of influence, including lawmakers |
| You can do it in an individual capacity                                           | Anybody can do this!                                                                                                |
| NAPHSIS does this on your behalf                                                  | Not governed by lobbying rules                                                                                      |



#### Model Law Advocacy

- Universal advocacy principles apply at the state level
- Is your state vital records law out of date?
- Educate state officials and policymakers on the importance of vital statistics and the work that you do
- Understand the new model law and what changes are necessary in your jurisdiction
- Internal advocacy is an important first step
- Work within the appropriate hierarchy in your jurisdiction





#### **Highlighting Vital Records**

- Demonstrate the importance of vital records to public health
- Help officials understand why vital records are important to individuals, the community, and the government
- Describe the work and value of your Vital Records Office
- Engage public health colleagues and organizations who use vital records





#### **Telling A Story**

#### Data makes you credible, stories make you memorable

- Frame your message to set the stage
- Keep it local
- Make it about the people in your community
- Convey how vital statistics help
  policymakers serve their constituents
- Use data to back up your story





#### Make Your Case Stand Out

- Legislators...
  - must rank competing priorities—why should they pick yours?
  - are driven to help their constituents
  - · influenced by stories from their communities, and
  - can be overwhelmed by a high volume of requests





#### **Understand Your Audience**

- What committees do your legislators serve on?
- What issues do they care about and highlight on their website? Newsletters? Social media?
- What relevant actions have they taken? What policies do they support?





#### **Keep it Simple**

- Focus on people and experiences more than policies and procedures; illustrate the policy you want to employ
- Use simple language; avoid jargon, technical terms, and acronyms
- Stick to your agenda
- Make your ask!





#### **Successful Meetings**

- Invite questions: make it a conversation
- Provide opportunities for follow up: If you don't know an answer, say you'll find out
- Employ active listening and ask your own questions
- Be respectful, but challenge positions if necessary
- Keep the conversation going!





#### **Build Lasting Relationships**

- Advocacy is a long-term commitment
- Ask for contact information
- Follow up and say THANK YOU
- Stay in touch with relevant information and news
