 - b. Resolution Authorizing the Issuance of the \$1,400,000, Paseo del Este Municipal Utility District No. 4, Unlimited Tax Bonds, Series 2025; Prescribing the Terms and Provisions Thereof; Levying and Pledging the Proceeds of Tax; Authorizing the Sale of the Bonds; Authorizing a Paying Agent/Registrar Agreement; and Containing Other Provisions relating to the Subject; and
 - c. Closing Procedures for the issuance and delivery of the \$1,400,000, Paseo del Este Municipal Utility District No. 4, Unlimited Tax Bonds, Series 2025.

Upon a motion made by Director Lascurain and seconded by Director Franco, the Board unanimously approved the foregoing actions.

- 5. The Board then considered the Developer's Report. Mr. Mercer provided a brief report on the development within the Paseo del Este MUDs. No action was taken by the Board. Ms. Avila left the meeting during discussion of this item.
- 6. As its final act of business, the Board next considered the Engineer's Report. Mr. Ortiz gave a brief report providing updates on the construction within the Paseo del Este MUDs. No action was taken by the Board.
