#### TVF CODE OF CONDUCT

## 1. Object.

The TVF Code of Conduct defines the most important values and principles for behaviour and conduct within TVF as well as with external parties. The Observance of the principles laid down in the Code of Conduct is essential to TVF and its obejctives, in particular to protect and improve the game of Volleyball constantly and promote it within Tanzania in the light of its unifying, educational, cultural and humanitarian values, particularly, through youth and development programmes and prevent any methods of practices with might jeopardise the intergrity of volleyball within the field of play and its administration.

## 2. Scope of Application.

The Code of Conduct applies to all members of the TVF family namely:

- Officials: Officials are all TVF Secretariet Members, TVF Committees' members, Regional Associations and its Committees, District Associations and its Committees, Clubs, Referees, Coaches, Trainers and any other persons responsible for technical, medical, administrative matters and any persons involved in association of Volleyball.
- ii) TVF employees.
- iii) Players.
- iv) Match Officials, Player's Managers as defined in the TVF Statutes.
- v) Leadership candidates.
- vi) TVF Honorary members and Trustees.

## 3. Core principles for behaviour and conduct of the TVF family.

### 3.5. Compliance with laws, rules and regulations.

We comply with all applicable volleyball laws and regulations and adhere to internal rules and regulations.

## 3.6. Avoidance of conflict of interest.

We act always in the best interests of TVF and its objectives. It is personal responsibility of each member of the TVF family to avoid any conflict of interest.
