**CALL FOR CONFERENCE GRANTS**

CLILNetLE COST Action *CLIL Network for Languages in Education: Towards bi- and multilingual disciplinary literacies* is happy to announce the opening of the current call for application for conference grants.

**ITC (Inclusiveness Target Countries) Conference grants** fund an oral presentation of an Action Participant's own work within the scope of the Action in a high-level conference fully organized by a third party, i.e. not organized nor co-organized by the COST Action. The Action Participant must be affiliated to a legal entity located in an Inclusiveness Target Country / Near Neighbour and be a YRI.

**DC (Dissemination Conference) grants** fund an oral presentation by an Action Participant of the work of the Action in a high-level conference fully organized by a third party, i.e., not organized nor co-organized by the COST Action. All Action Participants can apply.

**YRI (Young Researcher and Innovator) grants** funds a presentation (poster/oral presentation) of their own work within the scope of the Action by a Young Researcher and Innovator (YRI) in a high-level conference fully organized by a third party, i.e. not organized nor co-organized by the COST Action.

- **Scope:**

We are offering financial support through these grants for Action participants to present findings from the Action at international conferences. We are focusing our support on presentations of results and processes directly related to the Action Deliverables at international conferences on applied linguistics or language/subject education. To be awarded a grant, presentations or workshops need to be submitted to high-profile conferences with peer review.

- **Period:**

The conferences eligible for the Dissemination and ITC Conference Grants have to take place **before September 30th, 2026**.

- **Financial Support:**

Maximum 2500€ for face to face events.

Maximum 500€ for online events.

- **Selection criteria:**

Presentation of original papers, posters or workshops at international conferences, reporting findings and results which are clearly connected to the Action Deliverables.

Preference will be given to:

- Young researchers and innovators (<40 years old)
- Researchers from inclusiveness target countries (ITC)

- **Application deadline:**

The deadline for the application is the **25<sup>th</sup> May 2026**.

- **How to apply**

1. Fill in the appropriate application form (template available on e-COST) /specifying the amount needed alongside a specific list of estimated expenses.

2. Fill in e-COST form (<https://e-services.cost.eu/>)

3. Uploaded to e-COST system:

- Application form
- Copy of the abstract of the accepted oral or poster presentation
- Acceptance letter from the conference organisers
- Budget plan to include information on the conference fee, realistic estimates of transportations, accommodation and food (note that the daily allowance does NOT apply). For more information, please consult the ANNOTATED RULES FOR COST ACTIONS, v. 3.0 (Section A2-3, pp 103-104)

Note that only realistic expenses will be reimbursed.

- **Obligations:**

Grantees commit to write a post on the blog or twitter and send pictures of the presentation during the event for the social media network.

- **Reporting and claim for payment of the grant**

Upon the conclusion of the conference, within 30 days after the end of the activity, or, for activities taking place in September 2026, by 15<sup>th</sup> October 2026, the grantees have to submit the following via e-COST system

- The claim for the payment of the grant is made via e-COST system
- Report to the Action MC on the contacts made and potential for future collaborations
- The certificate of attendance
- The programme of the conference or book of abstracts / proceedings indicating the presentation of the grantee
- Copy of the given presentation (ppt).

**Clarifications:**

Grantees must make their own arrangements for all provisions related to personal security, health, taxation, social security and pension matters.
