If my company is ISO 27001 certified, am I AVG-ready?

While being ISO 27001 certified does not make you automatically ready for AVG, it does mean you likely already have a mature security framework in place. Having already inventoried your data incorporating security controls for your ISO certification, it should be easier to maintain AVG compliance.

Do I need to have a Data Protection Officer (DPO) and if I don't have one, who is responsible for AVG compliance?

It depends on your company's size, how much special category data you are processing, and if you are acting in a public body, such as government departments. If you decide not to hire a DPO, then you may want to incorporate AVG responsibilities within another role at your company. Keep in mind, AVG compliance is the responsibility of the company, there is no individual responsibility.
