1. What Cookies are and why the Company uses cookies

Cookies are small pieces of data or text which are placed on your computer when you are browsing a website, and used for collecting and tracking your activity on website, analysing trends for the purpose of our website administration, tracking user's browsing activity, or saving user's setting. Some of the cookies are essential since they help maintaining normal function of the website. 2. Which type of cookies the Company is using

2.1 Essential or Strictly Necessary Cookies

These cookies are necessary for you to browse and use several features on our website, such as accessing safe space on our website. We use strictly necessary cookies to ensure that our digital services provide its basic functions correctly and perfectly.

2.2 Performance and Analytics Cookies

We use performance cookies to calculate frequency and pattern of your site visits, such as your most visited page. We use this data to improve website efficiency and user experience.

_ga, _gid	This cookie name is associated with Google Universal Analytics – which is a significant update to Google's more commonly used analytics service. This cookie is used to distinguish unique users by assigning a randomly generated number as a client identifier. It is included in each page request in a site and used to calculate visitor, session and campaign data for the sites analytics reports.

2.3 Functionality Cookies

These cookies enable the website to remember your preferences, such as language, region, or other settings, to provide you with a more personalized and suitable user experience. If you do not allow these types of cookies, some parts of the website may not function as expected.

Currently, the website does not explicitly use these types of cookies, but if they are added in the future, the Company will update the information in this policy immediately.
