Pre-game Protocol	Officials' coin flip <i>The length of warmups will be determined by both head coaches and officials at the officials' coin flip, but will generally stick to the following procedure:</i> 20:00 pre-game warmup (total) 6:00 – shared court time, no net drills 7:00 – home team on full court 7:00 – away team on full court 1:00 – team huddle 0:00 – play begins
Match Length	Best of three sets, rally score to 25 each set, third set rally score to 15, no cap; must win by two
Time between sets	3-minute intermission
Timeout Length	1-minute timeouts
Home Team	The Home team (left team on the schedule) keeps the official scorebook. The visiting team provides the flip board scorekeeper. Please plan to keep your own scorebook for your games as well. There will be no line judges at the games.
Other Notes	Please bring practice balls. Bay City will provide game balls. There will be no locker rooms available. Please plan to keep your belongings with your team or stored in vehicles. There will be no awards, so teams are free to leave after their last scheduled game.
