Welcome



The Scheme is a superannuation scheme registered under the FMCA. The Scheme has also been recognised by His Majesty's Revenue and Customs (HMRC) as a Recognised Overseas Pension Scheme (ROPS).

Any contributions you make to the Scheme are used to purchase units in your chosen fund. The number of units that you purchase depends on the unit price at the time of the purchase. For example, if you contribute \$1,000, and the unit price is \$1.00 at that time, then 1,000 units will be purchased on your behalf. Unit prices are calculated daily and fluctuate according to the performance of each fund you are invested in.

Britannia Financial Services Limited, as the Manager of the Scheme confirms that:

- all the benefits required to be paid from the Scheme in accordance with the terms of the Governing Document and the Superannuation Scheme Rules under the Financial Markets Conduct Regulations have been paid; and
- the market value of the Scheme property at 31 March 2025 equalled or exceeded the total
 value of benefits that would have been payable had all members of the Scheme ceased to
 be members at that date and had provision been made for the continued payment of all
 benefits being paid to members and other beneficiaries as at 31 March 2025.

However, during the Year, ANZ Investments New Zealand Limited was removed as an investment manager of the Scheme and replaced with Nikko Asset Management New Zealand Limited (providing access to an underlying fund managed by Northern Trust), FundRock NZ Limited (hosting an underlying fund managed by Resolution Capital Limited) and Franklin Templeton Australia Limited (via an Integral Master Trust investment managed by Britannia Financial Services Limited).
